

**ORDINANCE NO. 20160811-028**

**AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND REQUIREMENTS, AND AUTHORIZE PAYMENT OF CERTAIN COSTS TO AUSTIN PRIDE FOUNDATION FOR THE CITY CO-SPONSORED 2016 AUSTIN PRIDE PARADE TO BE HELD ON AUGUST 27, 2016.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The City co-sponsored 2016 Austin PRIDE Parade will be held on Saturday, August 27, 2016.

**PART 2.** Council waives or reimburses certain fees under City Code Chapter 14-8, and authorizes payment of certain costs to Austin PRIDE Foundation for the Austin Pride Parade as follows.


