MINUTES

A. CALL TO ORDER

Chair Rivera called the meeting to order at 6:03 p.m.

B. APPROVAL OF MINUTES

1. Approve the minutes of the Parks and Recreation Board meeting of May 24, 2016.

Vice Chair DePalma made a motion to approve the minutes of the Parks and Recreation Board meeting of May 24, 2016. Board Member Luca seconded the motion. The motion carried on a vote of 7-0 with Board Members Cofer, Casias, and Vane off dais, and Board Member Schmitz absent.

C. CITIZEN COMMUNICATION

Robert Corbin addressed the board regarding his concerns about park visitors' use of hammocks, aerosol sunscreens, excessive noise, and dogs off leashes outside the designated "off leash areas".

D. NEW BUSINESS: DISCUSSION AND ACTION ITEMS Consent

- 2. Make a recommendation to the Director regarding the planned improvements for Little Stacy Neighborhood Park.
- 3. Make a recommendation to the Parks and Recreation Department Director for approval of Temporary Use (28,985 sq. ft.), not to exceed 60 Calendar Days on parkland located at 1000 Barton Springs Rd. (Butler Metro Park). Total Mitigation value is \$64,397.

Chair Rivera read item 2 and 3 into the record. Board Member Donovan moved to approve item 2 and 3 on the consent agenda. Board Member Alter seconded the motion. The motion carried on a vote of 9-0 with Board Member Vane off dais and Board Member Schmitz absent.

4. Approve the 2016 Bylaws for the Parks and Recreation Board

The Board discussed the proposed revisions of the Parks & Recreation Bylaws and proposed changes to § 2-1-165 – Parks and Recreation Board section of the City Code.

Board Member Casias made a motion to adopt (B) (1) section with amendments to read:

"(1) the acquisition, development, improvement, equipment, programming, and maintenance of all land and facilities managed by the Parks and Recreation Department the City of Austin;"

Board Member Cofer seconded the motion. The motion carried on a vote of 10-0, with Board Member Schmitz absent.

Vice Chair DePalma made a motion to adopt (B) (2) section with amendments to read:

"(2) the purchase of additional land and facilities to be managed by the City of Austin Parks and Recreation Department;"

Board Member Casias seconded the motion. The motion carried on a vote of 10-0, with Board Member Schmitz absent.

Board Member Vane made a motion to adopt section (C) with amendments to read:

"(C) The board shall outline a general plan of development for land, facilities, and programs. The board may submit the plan to the Planning Commission and the city manager for detail development, and the city manager may then submit the plan to the city council for approval."

Chair Rivera seconded the amended motion. Board Member Vane amended his motion to adopt (C) part section with the addition of:

[&]quot;as may be required by Code."

Chair Rivera seconded the amended motion. The motion carried on a vote of 10-0, with Board Member Schmitz absent.
