Additional Backup Information

The City of Austin is examining Austin Energy's base electric rates through a cost of service study and independent public rate review process. This process updates the utility's retail rates so they more closely recover the costs the utility incurs in the current operating environment. At the end of this process, Austin Energy's customers should have rates that fairly recover costs and reflect the community's priorities.

The public hearings represent the culmination of a seven-month public process adopted by City Council to review and debate Austin Energy's cost of service study and proposed retail rate design. The formal process enabled 23 intervenors representing all 11 customer classes to file nearly 400 documents, all of which are publicly available on the Austin City Clerk's website, and afforded over 30 hours of in-person debate in front of the Impartial Hearing Examiner. The public hearings provide constituents and ratepayers who may not have had the opportunity to participate in the Impartial Hearing Examiner process with the opportunity to express their views for the rate proposal directly to City Council.

After the latest rate review in 2012, the City Council required that electric rates be reviewed every five years. Any rate changes approved by Council this year are expected to take effect in January 2017. Portions of the electric bill which pay for pass-through costs such as energy purchases and access to the state grid will be reviewed as part of the overall budget process in summer 2016.

By regularly reviewing Austin Energy's cost structure through a cost of service study, Council gains a better idea of how much it costs to serve different types of customers, and a subsequent rate review provides insight into how customers should pay for those costs.

The City Council designated an Impartial Hearing Examiner to review information from the electric utility, stakeholders and customer groups. An Independent Consumer Advocate was selected to represent the interests of residential and small commercial customers. Members of the Electric Utility Commission will receive and summarize input from the community. The Impartial Hearing Examiner, Herrera & Boyle PLLC, will assist Council in establishing fair and balanced rates through the independent and impartial review of Austin Energy's recommendations and deliberate consideration of the concerns and opinions of the utility's customers. The Independent Consumer Advocate team, composed of John Coffman, Clarence Johnson and Janee Briesemeister, represents the interests of residential and small commercial customers as well as houses of worship.
