## Subject

Authorize award and execution of a 12-month contract with GRENIER SERVICES COMPANY, LLC, DBA CEDAR PARK OVERHEAD DOORS, to provide overhead door maintenance, repair, and replacement services, in an amount not to exceed \$525,000, with five 12-month extension options in an amount not to exceed \$750,000 per extension option, for a total contract amount not to exceed \$4,275,000.

## Amount and Source of Funding

Funding in the amount of \$87,500 is available in the Fiscal Year 2015-2016 Operating Budget of various City Departments. Funding for the remaining 10 months of the original contract period and extension options are contingent upon available funding in future budgets.

For the services required for this solicitation, there was insufficient subcontracting opportunities; therefore, no subcontracting goals were established.					
Additional Backup Information						

The contract will provide routine maintenance, repair, and replacement services of overhead doors for various City facilities including the Austin Convention Center, Austin Energy, the Austin Fire Department, Austin Water, Aviation, Building Services, Emergency Medical Services, and Parks and Recreation, as needed.

Overhead doors are constructed of a single leaf or multiple leaves, and open upwards from the ground level to facilitate the entry and exit of over-sized vehicles and equipment. This contract will ensure that the overhead doors in use at the City facilities are in good working condition and ensure operations of the City departments are not interrupted.

If a contract is not secured, door operation failures may increase. Several emergency response departments depend on the operations of these doors to respond quickly to emergency situations; door operation failures may increase response times to these emergencies. Overhead doors assist in securing City facilities and keep the operations of City departments functioning smoothly.
