PROPOSAL

Partial demolition to accommodate a new addition to the north and west elevations of the house.

PROJECT SPECIFICATIONS

The applicant proposes to add approximately 1,500 square feet to the house in two additions. The existing two-story sunporch to the left of the principal block of the house will be converted to enclosed space with vertical metal siding on the first floor, horizontal metal siding on the second floor, steel-framed windows, and a metal roof. There will be a new front door installed, and a cut stone ledge and bench in front of the house. A two-story connector between the right side of the house and the garage will have horizontal metal siding. A new hipped roof with metal sheathing will extend from the proposed connector across the garage door opening. The back of the house will have vertical metal siding on the proposed rear addition and steel-framed windows. The applicant is further proposing a metal awning which will require the removal of the existing balconet above the central front entry.

RESEARCH

This ca. 1938 Colonial Revival house was built by Earl and Marinda Middleton. Earl Middleton was in the wholesale grocery business in LaGrange, Eagle Lake, and Beaumont. He retired in 1938 and moved to Austin. After his death in 1945, his widow continued to live in this house until around 1957. Marinda Middleton was president of the Colonial Dames of the 17th Century and state organizer for the Huguenot Society. She also was a member of several colonial genealogical societies. The house was then owned by Cecil B., Jr. and Eleanor Smith. Cecil B. Smith, Jr. worked at his father's auto dealership. Around 1966, the house was purchased by Henry E. and Virginia Mecredy, who lived here through the 1990s. Henry E. ("Mac") Mecredy was from Virginia and was in the military until 1965, when he went to work for the City of Austin Planning Department. He retired from the city in 1980.

STANDARDS FOR REVIEW

The Old West Austin National Register Historic District has no design standards for additions to contributing houses. General design principles for additions to contributing houses in historic districts emphasize compatibility in terms of size, scale, materials, fenestration patterns, and massing with the house and other contributing houses within the district.

STAFF RECOMMENDATION

Staff had earlier recommended a change in the material for the addition, but upon further reflection, the metal siding will have a wood-like appearance, and while a non-traditional material for the historic district, it is compatible with the materials of the house. Staff recommends retaining the existing balconet and entry treatment for the house and removing the metal awning, which are not compatible with the district or the style of the house. Staff does not have an objection to the additions, although staff continues to believe that a more traditional material and fenestration pattern would be much more compatible with the style of the house, but staff definitely feels that the existing house should remain

untouched and not “modernized.” This is a classic example of Colonial Revival architecture and should not be compromised. Staff recommends the completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, to document the existing conditions at the house.

BIOGRAPHICAL NOTES

Earl and Marinda Middleton (ca. 1939 – ca. 1957)

His 1918 World War I draft registration card shows Earl Middleton living in Victoria, Texas, where he was the manager of the Schuhmacher Company, a wholesale grocery company. He was born in 1874, was of tall stature and had a stout build. He had red hair and blue eyes.

The 1920 U.S. Census shows E. and Mrs. M. Middleton as the renters of a house in Victoria, Texas. Earl Middleton was 45, had been born in Illinois, and was the manager of a wholesale grocery business. Marinda Middleton was 43, had been born in Illinois, and had no occupation listed. They had 3 sons: E.B., 22; B.W., 19; and J.D., 14. All of the boys had been born in Illinois, and all were students – the two older boys at the university. With them lived Earl's mother, an 82-year old Ohio-born widow with no occupation listed.

The 1930 U.S. Census shows Earl and Marinda Middleton as the renters of a house in Beaumont, Texas, where Earl Middleton was the manager of a wholesale grocery business. Marinda Middleton had no occupation listed. None of their children were listed with them.

His 1945 death certificate shows that Earl Middleton was living in this house at the time of his death. He was born in 1874 in Jacksonville, Illinois to the Rev. Samuel Middleton and his wife, Margaret. He was a wholesale grocer.

Her 1957 death certificate shows that Marinda Middleton was living in this house at the time of her death. She was born in 1876 in Gifford, Illinois. She was a housewife.

EARL MIDDLETON

Earl Middleton, 70, Austin resident for about seven years, died in a local hospital Sunday morning. He was a prominent wholesale groceryman, having been associated with the Schuhmacher company since 1908. He was branch manager in La Grange, Eagle Lake and Beaumont where he retired in 1938 and moved to Austin. Middleton was a member of the Central Christian church, Macon Lodge No. 8 AF & AM, Decatur, Ill., Eastern Star, a member of the Knights Templar commandery in Beaumont and the Shrine in Galveston.

Survivors are his wife, Mrs. E. Middleton, Austin; two sons, Dr. E. B. Middleton, College Station and J. Bent Middleton, Dallas. Three grandchildren also survive.

Funeral services will be conducted at the Weed-Corley Funeral services will be conducted at the home Monday at 5 p. m. The Rev. Jack Suggs will officiate and burial will be in Oakwood cemetery.

Mrs. Earl Middleton, 80, died Tuesday at 1:30 p.m. at her home, 1714 Cromwell Hill.

Funeral services will be held at Weed-Corley Funeral Home Wednesday at 2 p.m. with Rev. Lawrence Bash officiating. Burial will be in Oakwood Cemetery.

Mrs. Middleton had been a resident of Texas since 1907. She moved to Austin from Beaumont in 1937.

She was a past president-general of the Colonial Dames of the 17th Century and state organizer

for the Huguenot Society. She was also a member of the Daughters of 1812, Daughters of the American Revolution, Dames of the Court of Honor, American Colonists, and of Capitol Chapter 803, Order of the Eastern Star.

She is survived by two sons, J. D. Middleton of Austin and Errol Middleton of Bryan; three sisters, Mrs. L. F. Brannon of New Rochelle, N.Y., Mrs. D. C. Walker of Butte, Mont., and Mrs. Deb Ward of Harlingen; and three grandchildren.

Henry Edwards Mecredy, Jr., 90, of Austin, died September 8, 2006 at the William R. Courtney Texas State Veterans Home in Temple after a brief illness. Services are under the direction of Sheffield Funeral Home of Temple.

Mac is survived by his wife of 63 years, Ginger and their children, Henry Mecredy, III, Bill Mecredy and his wife Wendy, Martha Butler and Virginia Ann Mecredy, all of Austin. He is also survived by his grandchildren Patrick Mecredy of Houston, Evan Mecredy, Sean Mecredy, Sarah Butler and Ryan Mecredy, all of Austin, and by his siblings, Jim Mecredy of Martinez, Georgia and Jane Mecredy of Dolores, Colorado.

Mac was born in City Point, Virginia on June 2, 1916 and grew up in Roanoke, Virginia. He graduated from the Virginia Military Institute in 1941. While posted at Camp Hood, Texas he met Virginia Ann Taylor of Temple and they were married on December 24, 1942. During World War II, Mac served in the South Pacific. After the war he served in Korea, Japan, Germany, Oklahoma and Virginia before retiring as a Lieutenant Colonel in 1965. Mac also worked in the City of Austin Planning Department until his retirement in 1980.

Mac's remains will be cremated and his ashes spread at VMI and at the family plot in the Little River - Wilson Valley Cemetery in Little River, Texas. Private family services will be held in the near future.
