- parking for the hundred's of music-goes, who then have to park on the street in front of our house and return to their cases drunk and loud
- early, so our bedtone is 9pm. We cannot fall asleep until the music has stopped and the loud guests have 1eft the street in front of our house which means 10-11pm Sun-Thurs and 12-lam Fri-Sit, with the current permit.
- There are many residences within a few hundred fect of the Scoot Inn that have expressed similar concerns as mine.
