Citizen Communications

Citizens wishing to speak on the agenda and non-agenda related items will need to sign up ten minutes before the meeting is called to order. Non-agenda related citizen communications will be discussed during this period and will be limited to the first 5 speakers. Citizen Communications on agenda related items will be allowed after an item's presentation has been made. Each citizen communicator will be given 3 minutes to speak.

A person who intends to speak during speaking time must register in person. A person may register before the last person who has registered to testify on the item has begun to testify.

If a formal public hearing has been held and closed on the subject matter of an agenda item, a person may not register to speak on the item at a subsequent commission meeting.

A person may donate the person's speaking time on an agenda item or at a public hearing to another speaker if the person donating the time is present when the speaker begins to address the commission. A speaker may not use the time of more than four other registered speakers on an agenda item or at a public hearing.

Except as required by state law, the commission may limit the number of speakers or the length of testimony at the commission's discretion.
