The contract is for a turned-key integrated electronic health records management system for the Health and Human Services Department (HHSD). This system will replace current disparate applications with an integrated solution to be used to manage single case files (single customer record) across various programs and services. The ability to access the integrated patient health records will improve the overall coordination of patients care, referrals, and outcome. The system will increase the efficiencies in billing/revenue cycle management and the disposition of data after meeting the retention requirements ensuring compliance with Health Insurance Portability and Accountability Act privacy and security regulations. The system will provide capability for the future connection to the Texas Health Information Exchange (HIE).

An evaluation team with expertise in this area evaluated the offers and scored eClinicalWorks, LLC. as the best to provide these services based on price, use case and functional requirements, specifications, vendor support, concept and solution, personnel, project management structure, experience and references, and local business presence.

This request allows for the development of a contract with a qualified offeror that Council selects. If the City is unsuccessful in negotiating a satisfactory contract with the selected offeror, negotiations will cease with that provider. Staff will return to Council so Council may select another qualified offeror and authorize contract negotiations with this provider.

If this request is not approved, the HHSD will have to maintain older, costly systems with minimal security and no interoperability. The HHSD would not be able to participate in a HIE, establish revenue cycle management capabilities or perform data analysis for continuous quality improvement plans.
