MBE/WBE:	This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this solicitation, there were insufficient subcontracting opportunities; therefore, no subcontracting goals were established.				

The contract provides secure onsite and offsite shredding services for all City departments. The services include the collection of onsite containers located at various city facilities. The Contractor will shred the content in the secured containers either onsite or offsite as requested by the department. Shredding services are necessary in order to properly dispose of confidential or proprietary documents, films, photographs, blueprints, credit cards, microfiche, transparencies, computer disks, or videos.

Austin Water has 18 containers that are located at various Austin Water sites.

The Contractor will recycle any materials that are eligible to be recycled. The Contractor is a local vendor which employs Austin residents.

If a contract is not secured, departments will be unable to securely shred confidential or proprietary materials.
