

## Recommendation for Water & Wastewater Commission

SUBJECT

Authorize award and execution of a 36-month contract **MELENDREZ TRUCKING, LLC** (WBE), to provide aggregate materials, in an amount not to exceed \$631,239, with three 12-month extension options in an amount not to exceed \$210,413 per extension option, for a total contract amount not to exceed \$1,262,478.

## AMOUNT AND SOURCE OF FUNDING

Funding in the amount of \$192,879 is available in the Fiscal Year 2016-2017 Operating Budget of Austin Water. Funding for the remaining 25 months of the original contract period and extension options are contingent upon available funding in future budgets.

Purchasing Language:	The Purchasing Office issued an Invitation for Bids (IFB) EAD0253 for these goods on June 13, 2016 and it closed on July 19, 2016 with four offers received. The recommended offer is the lowest offer submitted by a responsible offeror. Additional information on the solicitation is included below the line. The recommended offeror is not the current provider for these goods.

MBE/WBE:	This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program and subcontractor goals were applied to the solicitation. The subcontracting goals were met and the resulting contract will include 46.4% WBE participation.

The contract will provide gem sand and washed gravel aggregate for projects at various locations and worksites throughout the City. The aggregates provide pipe bedding for water and wastewater lines, stable footing for piping and foundation support for manhole and meter vaults. Once aggregate is placed it provides visualization of buried utilities for the excavator to prevent broken water lines. The material is in accordance with national, state and City of Austin construction standards for water infrastructure installations and repairs.

If the City is unable to secure the contract, the time line projection of City water and wastewater lines installations and repairs would be greatly affected and could cause undue delays awaiting the purchasing of material per project and create storage concerns of material that would be delivered to site.
