PROPOSAL

Demolish a ca. 1935 house.

ARCHITECTURE

One-story, rectangular-plan, board-and-batten frame house with a shed-roofed entry hood over the off-set front door; single 1:1 fenestration.

RESEARCH

The house was built in 1935 by local builder Fred C. Morse. The first tenants were William and Ruby Barnett, who lived here until around 1938. William Barnett was a bricklayer. From around 1938 until around 1943, the house was rented by Edward and Hattie Lockwood. Edward Lockwood was a chauffeur for Patton's baggage transfer service at the time that he and Hattie moved into this house; he later became a taxi driver.

After the Lockwoods moved around 1943, the house was owned and occupied by Jesse and Beatrice Ledesma, who lived here until around 1950, when they moved next door to 2511 Hidalgo Street. Jesse Ledesma was a bartender at Dinty Moore's Café and Bar on W. 6th Street downtown. After another period of rental in the early 1950s, the house was purchased by Frank and Angelina Arzola, who lived here until around 1960. Frank Arzola was a driver for a building materials company. He sold the house to his brother, Richard Arzola, who with his wife, Mary and their family, lived here until the late 1960s. Richard Arzola was a printer for a duplicating firm. The house has been a rental property since the late 1960s.

STAFF COMMENTS

The house is not listed in any City survey to date.




STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to qualify as a historic landmark.

BIOGRAPHICAL NOTES:**Edward and Hattie Lockwood (ca. 1938 – ca. 1943)**

The 1930 U.S. Census shows Ed and Hattie Lockwood as the renters of the house at 93 East Avenue in Austin. Ed Lockwood was 36, had been born in Texas, and was a truck driver for a private firm. Hattie Lockwood was 36, had been born in Texas to German-born parents, and was a waitress in a café. They had no children listed with them.

Jesse O. and Beatrice C. Ledesma (ca. 1943 – ca. 1951)

The 1940 U.S. Census shows Jesse and Beatrice Ledesma as the renters of the house at 1218 Inks Avenue in Austin. Jesse Ledesma was 25, had been born in Texas, and was a clerk in a package store. Beatrice Ledesma was 24, had been born in Texas, and had no occupation listed. They had a daughter, Virginia, 1, who had been born in Texas.

Jesse O. Ledesma, age 75, of Austin, passed away Sunday.

He was a lifetime resident of Austin and owned and operated Ledesma Barber Shop for over 35 years. He later retired from the state after 12 years.

Beatrice C. Ledesma passed away on Tuesday, October 14, 2008 at the age of 93. She was born on July 8, 1915 in Austin, Texas. Beatrice was preceded in death by her parents, and her husband of over 50 years, Jesses O. Ledesma, and a grandson, Gregory Cano III.

She is survived by her daughter, Virginia Camarillo and husband Joe; her son, Jesse C. Ledesma and wife Susan; and her daughter, Dolores Shecter and husband Lou; eight grandchildren, Carolyn Hammond (West), Eric Camarillo, Jerry Cano (Kelli), Stephanie Cano, Rebecca Cano Tate (Tim), Cindy Acuna (Joey), Michael Ledesma (Patricia A.), and Patricia Mercado; and seventeen great-grandchildren, plus hundreds of other "grandkids" from her Dell Children's Hospital family who all knew her by "Grandma Bea". Her family was so proud of her and of all her accomplishments during her dedicated service to her community.

She traveled to many of her grandchildren's baseball, football and cheerleading tournaments, loved to play bingo, watch Jay Leno and the Texas Longhorns play football, and enjoyed every single day of her life. She was known for always having a warm smile and happy greeting. One minute with her and you had a friend for life.
