A. Coleman asked for follow up on the scope of the Design Commission's ordinance to verify if the airport is exempt from Design Commission review and why. City Architect (Kit Johnson) suggested an official letter from the Commission formally requesting / directing staff to look into the issue. A. Coleman made a motion to request verification from Airport group that the project is exempt from Design Commission's review and why (or, if it's not, why it didn't come before the Commission), and, drawings for Design Commission's review to see how project fits within the public realm. B. Luckens seconded. Discussion included D. Carroll suggesting going higher up, E. Taniguchi suggesting the Director of Aviation, C. Kenny suggesting the Legal Dept. A.
