

ORDINANCE NO. _____

1 AN ORDINANCE ANNEXING, FOR FULL PURPOSES, ADDITIONAL
2 TERRITORY ADJACENT TO THE CITY LIMITS OF THE CITY OF AUSTIN
3 REFERRED TO AS THE "MOORELAND ADDITION" ANNEXATION AREA,
4 CONSISTING OF APPROXIMATELY 34 ACRES OF LAND IN
5 SOUTHWESTERN TRAVIS COUNTY, TEXAS; AND APROVING A SERVICE
6 PLAN

8 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

10 **PART 1.** The Council finds that:

12 (A) Notice of the two public hearings concerning annexation of the territory
13 described in Exhibit A was published in a newspaper of general circulation
14 in the City of Austin and in the area to be annexed, and on the City of Austin
15 website.
- 16
17 (B) The public hearings were held on October 6, 2016 and October 13, 2016, at
18 the Austin City Hall, 301 West 2nd Street, Austin, Texas.
- 19
20 (C) The public hearings were concluded after providing an opportunity for all
21 persons present to be heard with respect to the proposed annexation. A
22 proposed Service Plan was made available and explained at the public
23 hearings required by law.
- 24
25 (D) The annexation, for full purposes, of the territory described in Exhibit A
26 serves the interest of the current and future residents of the City of Austin.
- 27
28 (E) All procedural requirements imposed by state law for the full purpose
29 annexation of the territory described in Exhibit A have been met.

30
31 **PART 2.** The present boundary limits of the City are amended to include the
32 following territory which is within the extraterritorial jurisdiction and adjacent to the city
33 limits of the City of Austin in Travis County, Texas and which is annexed into the City
34 for full purposes:

36 Approximately 34 acres located in southwestern Travis County east of the
37 intersection of Manchaca Road and Mooreland Drive, this area is more particularly
38 described in Exhibit A.

1 **PART 3.** The Service Plan attached as Exhibit B is approved as the Service Plan for
2 the area.
3

4 **PART 4.** The City Council declares that its purpose is to annex to the City of Austin
5 each part of the area described in Exhibit A as provided in this ordinance, whether any
6 other part of the described area is effectively annexed to the City. If this ordinance is
7 held invalid as to part of the area annexed to the City of Austin, the invalidity does not
8 affect the effectiveness of this ordinance as to the remainder of the area.
9

10 If any area or lands included within the description of the area set out in Exhibit A are:
11 (1) presently part of and included within the general limits of the City of Austin; (2)
12 presently part of and included within the limits of any other city, town or village; or (3)
13 are not within the jurisdiction of the City of Austin to annex, then that area is excluded
14 and excepted from the area annexed.
15

16 **PART 5.** This ordinance takes effect on December 15, 2016.
