

#### **Art in Public Places Panel**

#### **REGULAR MEETING MINUTES**

The Art in Public Places Panel convened a regular meeting on Monday, September 12, 2016, at 201 E. 2<sup>nd</sup> Street, Austin, Texas.

#### 2. APPROVAL OF MINUTES

Sue Lambe provided a brief introduction to the project. Robert Mercado provided an overview of the current design of the facility and construction schedule. Sue Lambe presented possible artwork opportunities and selection process procedures. Discussion ensued.

b. Presentation for Sabine Street Promenade AIPP Project Mid Design Review

Artist Andrea Legge presented the Mid Design for the Sabine Street Promenade AIPP Project for the Legge Lewis Legge team. Discussion ensued.

c. Discussion and Possible Action regarding the Allied Artist Program Policy
-- Sue Lambe, AIPP Program Administrator

Sue Lambe presented an overview of the Allied Artist Program Policy to include an open roster for artist selected. Discussion ensued. The Panel recommended revisions to the policy. AIPP staff will bring the item back to the panel after the revisions are incorporated into the policy.

Sue Lambe informed the Panel that the Austin Energy Cooling Plant project was pulled from the September 22 Council agenda due to issues with the project's proposed funding sources. Staff will bring back the prospectus for a third revision to the Panel. Anna Bradley updated the Panel on the TEMPO 2016 installations and events. The Long Center was recommended as the retreat location for the AIPP Panel to take place in November 2016 and a possible 'buddy' system for AIPP Panelists and AAC Members.
