ORDINANCE NO. 20161110-009

AN ORDINANCE AMENDING ORDINANCE NO. 20090827-078 TO CORRECT A REFERENCE TO THE ZONING FOR PROPERTY DESCRIBED IN ZONING FILE C14-2009-0055.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Findings

- A. City Council adopted Ordinance No. 040513-33A on May 13, 2004. The approved zoning districts were incorrectly assigned on the City's zoning map for properties located at 5525, 5531, and 5605 Burnet Road.
- B. City Council adopted Ordinance No. 20090827-078 on August 27, 2009, that applied a vertical mixed use building overlay (V) to certain properties identified in Ordinance No. 040513-33A. The previous zoning map error continued to be reflected in both the table section of Part 2 of Ordinance No. 20090827-078 and the City's zoning map for the properties located at 5525, 5531, and 5605 Burnet Road.
- C. With respect to the zoning of the properties located at 5525, 5531, and 5605 Burnet Road, the zoning was unaffected by the mapping error reflected in the City's zoning map and table of Ordinance No. 20090827-078.

PART 2. Part 2 of the table section of Ordinance No. 20090827-078 is amended to read as follows:

PART 5. This ordinance takes effect on November 21, 2016.


