Mission Statement:

The Small Area Planning Joint Committee is an advisory body to City Council and the Land Use Commissions. With a holistic overview of planning and zoning matters, it addresses reactive and specific issues from the Land Use Commissions and City Council. In addition, it evaluates the proactive process of planning focused areas in the City. Due to the limited public attendance and input, our recommendations and resolutions shall serve as general policy guidance to the Land Use Commissions and City Council.

Strategic Work Plan:

- Assist City staff with matters regarding the selection process for future planning areas
- Review small area plans as they become available
- In matters regarding planning for small areas, create consistency in approach between the Planning Commission and Zoning and Platting Commission by determining roles of each in the process and how to best use the joint committee in doing so.
- Study the concept of Complete Communities to create a common evaluation system for use by the Land Use Commissions.
- With respect to the Waterfront Overlay Combining District:
 - Becoming more aware of Code provisions of the Waterfront Overlay
 - Review variances and other planning issues within the Waterfront Overlay Combining District

The motion passed on a vote of 5-0. Commissioners Rojas and Thompson were absent.
