# 2. APPROVAL OF MINUTES

#### 4. NEW BUSINESS

a. Plan Amendment for the Bouldin Creek Neighborhood Plan — Discussion and possible action to amend the Bouldin Creek Neighborhood Plan to adopt the Garage Placement Infill tool. (Sponsor Chair James Shieh, Co-sponsor Commissioner Trinity White)

Motion to recommend to the Planning Commission that they initiate a zoning change for the Bouldin Creek Neighborhood Planning Area to adopt the Garage Placement Design Tool was made by Commissioner Harris and seconded and approved on a vote of 5-0. Commissioners Rojas and Oliver were absent.

b. **Discussion of Complete Communities** — The Small Area Planning Joint Committee will discuss the *Imagine Austin Comprehensive Plan* concept of complete communities. (Discussion and/or Possible Action)

Roger Cauvin presented to the Committee ideas about the Imagine Austin Comprehensive Plan complete community indicators and discussed the five-year update of the plan. Following a discussion a motion was made and seconded to continue this item at the October 5<sup>th</sup> meeting. The motion was approved on a vote of 5-0. Commissioners Rojas and Oliver were absent.

c. Development and land use issues along the East Cesar Chavez Street corridor — Discussion of Planning Commission's request to consider restricting certain land uses along the East Cesar Chavez street corridor from I-35 to US 183 and/or develop land use regulations to address development-related issues and associated community concerns (Discussion and/or Possible Action)

The motion was made and seconded to continue this discussion at the October 5<sup>th</sup> Small Area Planning Joint Committee meeting and approved on a vote of 5-0. Commissioners Rojas and Oliver were absent. There was a request of staff to provide a detailed map of the East Cesar Chavez corridor as well as other supporting materials.
