2. APPROVAL OF MINUTES

Commissioner Kiolbassa moved to approve support of the Lamar Beach Master Plan to Planning Commission and City Council, second by Commissioner Thompson, with the following recommendations:

- 2. Consideration of a pedestrian gateway on Pressler
- 3. Consideration of a bus pull-in to accommodate future bus service
