(12/15) Authorize execution of a 24-month Indefinite Delivery/Indefinite Quantity construction services contract with BILFINGER WESTCON, INC., for the installation of chilled water piping construction in the right-of-way, in an amount not to exceed \$6,000,000 for an initial 24-month term, with three 12-month extension option, for a total contract amount not to exceed \$15,000,000. [Note: Capital Contracting Office]
- 3. (12/15) Authorize negotiation and execution of 60-month contract through the STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES cooperative purchasing program with MARK III SYSTEMS, to provide International Business Machines and Lenovo products and services including maintenance and support, in an amount not to exceed \$11,500,000.

(12/15) Authorize negotiation and execution of a 12-month contract with CENTRAL TEXAS COMMERCIAL A/C & HEATING INC., to provide rental of portable utility plant equipment, in an amount not to exceed \$600,000, with four 12-month extension options in an amount not to exceed \$300,000 per extension option, for a total contract amount not to exceed \$1,800,000.
- 5. (12/15) Authorize negotiation and execution of a 36-month contract with DOBLE ENGINEERING COMPANY, to provide test equipment and consulting services, in an amount not to exceed \$330,690,

- with two 12-month extension options in an amount of \$118,497 for the first extension option and \$121,460 for the second extension option, for a total contract amount not to exceed \$570,647.
