

M/WBE Summary

Public notice was given for this solicitation, CLMC619 WW Line Renewal & Spot Rehab Svc-2017-2019 IDIQ, through the City's Vendor Connection web portal which resulted in 529 contractors receiving notification. Seventy-four contractors obtained the bid documents and seven bids were received and opened on October 13, 2016. Three out of the seven bids received are MBE/WBE certified firms. Santa Clara Construction, Ltd. submitted the lowest responsive bid:
