1. APPROVAL OF MINUTES

2. NEW BUSINESS

a. Consider and act upon a request to postpone the disciplinary appeal hearing of Fire Specialist Ryan Thompson before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission no later than April 3, 2017.

- Commission Vice Chair Harris made the motion to postpone the disciplinary hearing. Commission Chair Canales-Zarate second the motion and the motion pass 2-0 to postpone the disciplinary appeal hearing for Fire Specialist Ryan Thompson no later than April 3, 2017.
- b. Consider and act upon a request to postpone the disciplinary appeal hearing of Fire Lieutenant Jamie Baxter before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission no later than April 3, 2017.
 - Commission Vice Chair Harris made the motion to postpone the disciplinary hearing. Commission Chair Canales-Zarate second the motion and the motion pass 2-0 to postpone the disciplinary appeal hearing for Fire Lieutenant Jamie Baxter no later than April 3, 2017.
- c. Hear and act upon a disciplinary appeal from Fire Specialist Daryl Burns before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission for a 4-hour suspension.
 - Commission Vice Chair Harris made the motion to sustain the charge against Fire Specialist Daryl Burns. Commission Chair Eyna Canales-Zarate second the motion, and the motion pass 2-0 to sustain the decision of the Fire Chief to temporarily suspend Fire Specialist Burns for a period of four (4) hours.
- d. Hear and act upon a disciplinary appeal from Fire Specialist Daryl Burns before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission for a 2-day suspension.
 - Commission Vice Chair Harris made the motion to sustain the charge against Fire Specialist Daryl Burns, however reduce the temporary suspension to a period of eight (8) hours. Commission Chair Eyna Canales-Zarate second the motion, and the motion pass 2-0 to sustain the decision of the Fire Chief to temporarily suspend Fire Specialist Burns but reduce the temporary suspension to a period of eight (8) hours.
- e. Hear and act upon a disciplinary appeal from Fire Lieutenant Gregory Pope before the Firefighters', Police Officers' and Emergency Medical Services Personnel's Civil Service Commission for a 3-hour suspension.
 - Commission Vice Chair Harris made the motion to sustain the charge against Fire Lieutenant Pope. Commission Chair Canales-Zarate second the motion and the motion pass 2-0 to sustain the decision of the Fire Chief to temporarily suspend Lieutenant Pope for a period of three (3) hours.
