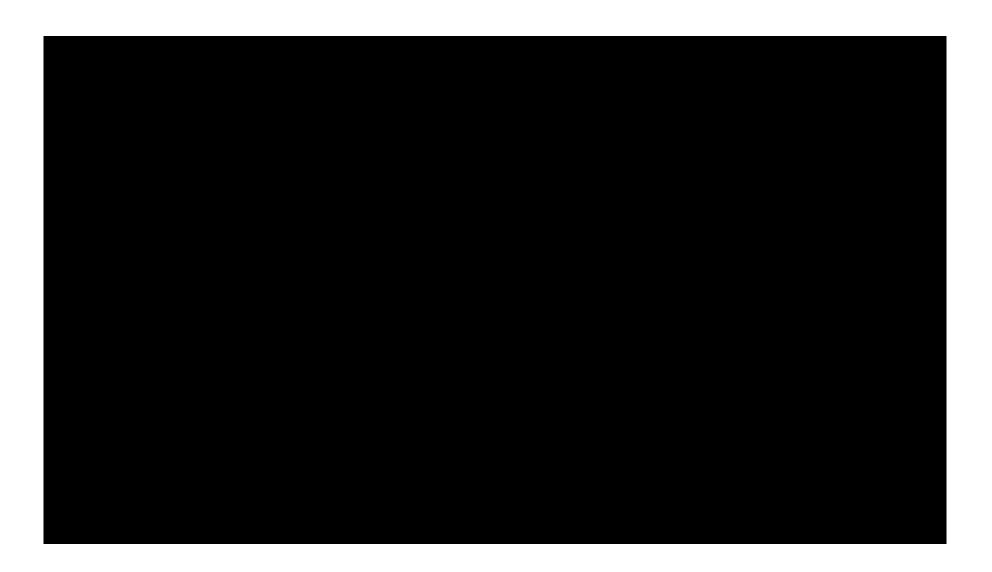

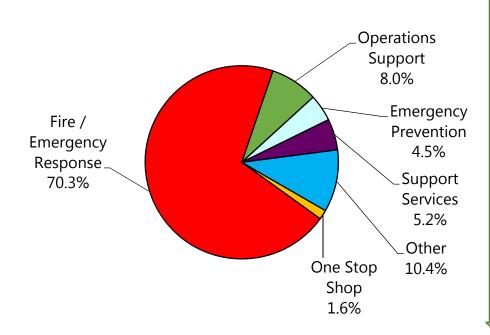

- Support Services & Other include administration functions & City transfers

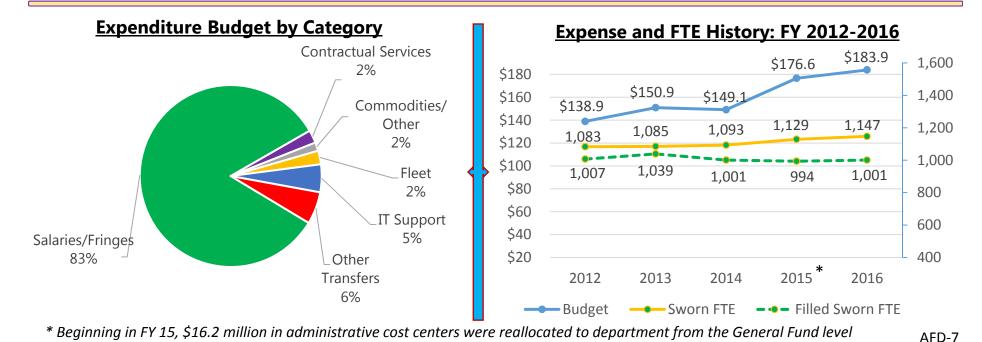

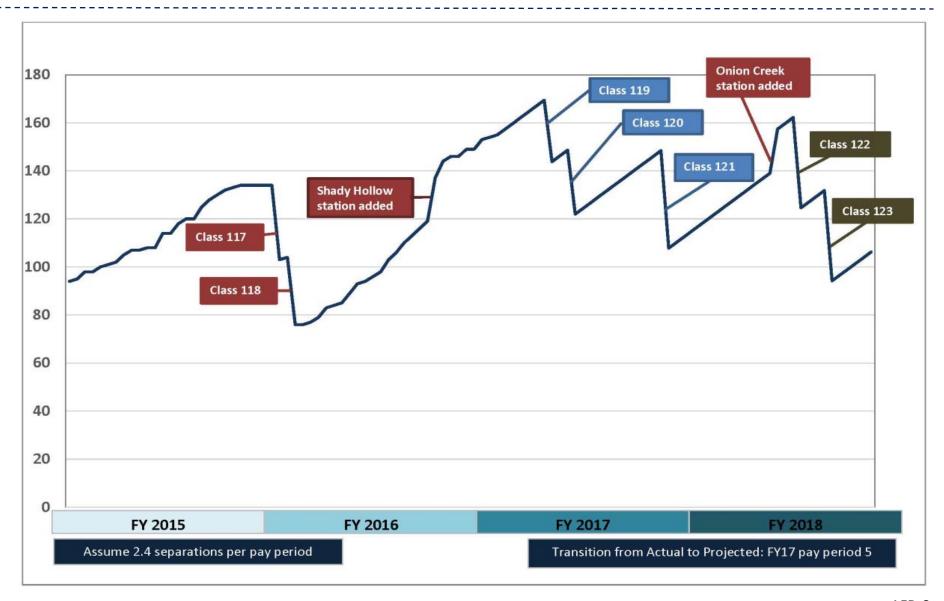

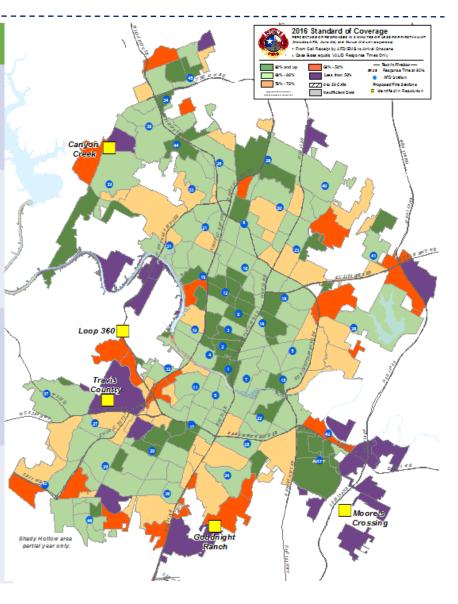

RESOLUTION NO 20071101-038

WHEREAS, the City Council Recognizes public safety as a top priority, and

WHEREAS, the Austin Fire Department is tasked with protecting the lives and property of the citizens of Austin, and

WHEREAS, many studies, including one carried out here in Austin, have shown that increasing firefighter staffing levels has a positive impact on safety and efficiency during Fire Department Operations, and

WHEREAS, the National Fire Protection Association's NFPA 1710 Standard requires a minimum of four firefighters per each firefighting apparatus, NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN

The City Council adopt Austin Fire Department Staffing, as defined below, as the minimum staffing requirement of the Austin Fire Department and direct the City Manager implement this standard, and

BE IT FURTHER RESOLVED

Beginning in January 2008, the City will implement a minimum staffing policy for the Austin Fire Department and that staffing model will be completed by 2019 or sooner, if at all possible, and

RESOLUTION NO. 20070809-036

WHEREAS, the City of Austin has consistently worked to provide a diverse workplace; and

WHEREAS, diversity equates not only to a numerically diverse workforce, but also equates to a workplace that provides facilities of equal or comparable nature; and

WHEREAS, the Austin Fire Department currently employs female fighters; and

WHEREAS, the stations where female fire fighters live and work often do not have equal or comparable facilities; and

WHEREAS, the City of Austin should make a commitment to providing equal or comparable facilities for female fire fighters as they provide much needed diversity in the Fire Department; NOW, THEREFORE.

RESOLUTION NO. 20160324-009

WHEREAS, the Austin Fire Department uses a standard of 8 minute response times 90% of the time, which is consistent with national standards set by the Commission of Fire Accreditation International and the National Fire Protection Association; and

WHEREAS, in calendar year 2015, roughly 20% of the city met the established response time goal of 8 minutes or less 90% of the time; and

WHEREAS, according to the City of Austin Demographer, Austin's population grew over 38% over the last fifteen years; and

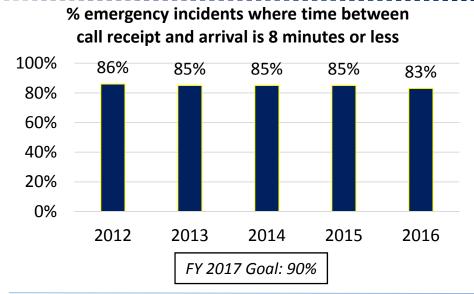
WHEREAS, as Austin's population continues to grow, the need for services will also increase; and

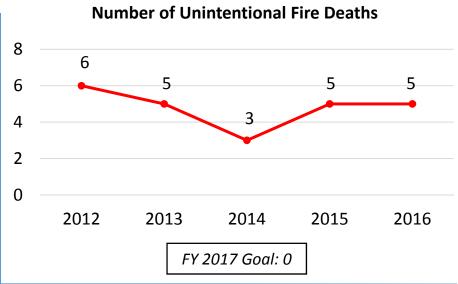
WHEREAS, the Austin Fire Department and The Austin Firefighters Association collaborated to update the 1994 Fire Station Justification Model, now called the Fire Station Risk and Service Delivery Analysis Model (Service Delivery Analysis), which provides data driven information to allow policymakers to proactively make informed decisions about the need for future fire station location and timing; and

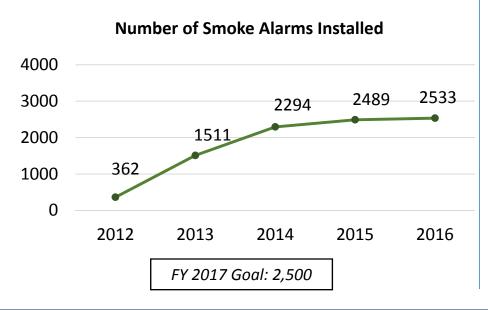
WHEREAS, the 2016 Service Delivery Analysis determined there was an immediate need for fire stations in five areas with "significant development, increased population, and response times which are substantially below AFD's goal of 8 mins (call receipt to on scene, 90%)," which include the Travis Country area, the Loop 360 area, the Goodnight Ranch area, the Moore's Crossing area, and the Canyon Creek area; and

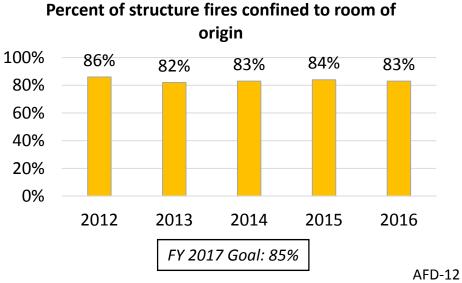
