In addition to the "President's Budget FY 2017" column above, the Administration's DOT budget proposes the following new initiatives that would be funded through a proposed \$10/barrel oil fee:

- Climate-Smart Performance Formula Funds Program: \$2 billion in FY 2017 (\$16.5 billion over 10 years) to incentivize states to invest in transportation projects that are demonstrated to reduce greenhouse gas emissions, such as rail infrastructure and infrastructure supporting transit-oriented development.
- 21st Century Regions Grant Program: \$1 billion (\$61 billion over 10 years) to promote regional transportation and land use plans that reflect changing demographics and economy of country, reduce greenhouse gas emissions, and improve transportation of people and goods.
- Clean Communities Grant Program: \$1 billion (\$14.5 billion over 10 years) for competitive grants to local governments to encourage climate-smart development and achieve regional greenhouse gas and vehicle-miles-travelled reduction goals.
- Resilient Transportation Grant Program: \$1.5 billion (\$7.5 billion over 10 years) to encourage State and local governments to propose specific projects that address the impacts of climate change on all types of transportation systems and surrounding communities.
- Future Freight System Program: \$2 billion (\$10 billion over 10 years) to provide targeted, competitive grants to State and local agencies for innovative rail, highway, port and intermodal projects that help transform the current freight system into a highly efficient, multi-modal system.
- Bus Rapid Transit Discretionary Grant program: \$575 million to "communities with fast growing populations."

For passenger rail programs at the Federal Railroad Administration, the President's budget proposes combining most agency programs (including Amtrak) into two accounts that would be funded through the Highway Trust Fund (which would be renamed the Transportation Trust Fund): \$2.3 billion in FY 2017 for Current Passenger Rail Service and \$3.7 billion in FY 2017 for the Rail Service Improvement Program. Amtrak would receive \$1.9 billion in the Current Service pot, with the remaining \$400 million going toward a rail state of good repair program. Development of "high performance rail corridors" would receive \$1.5 billion from the latter account, and \$1.3 billion would be used for Positive Train Control Implementation.
