

M/WBE Summary

Participation subgoals stated in the solicitation were 1.90% African American; 9.00% Hispanic; 4.90% Native America/Asian; 15.80% WBE. The recommended firm provided a MBE /WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department. The alternate firm provided a MBE /WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

Notification of issuance of a Request for Qualifications on November 10, 2016 through the City's Vendor Connection web portal resulted in 2,316 firms receiving notice. The solicitation was obtained by 178 firms. Four firms submitted statements of qualifications. None of the firms submitting were a certified MBE /WBE.
