- **Phase III** – ***Aquatic Master Plan Development*** – IN PROGRESS



The Aquatic Master Plan Addresses:

- Financial Sustainability of proposed system
- Staffing requirements and needs
- Public and Environmental Safety considerations
- Operations/Maintenance cost of existing and potential new aquatic system
- Pool facility concept development
- Potential for existing facility renovation, expansion, consolidation, or decommissioning
- The Aquatic Division need to evaluate and factually guide opportunities and constraints relative to the aquatic system for the next 20 to 25 years

Aquatic Facility Classifications



Classification	Service Area	Pool Square Feet	Features
Neighborhood Pool	20-minute walk	3,000 – 5,000 S.F.	Lap and Activity Pool
Community Pool	10-minute drive	5,000 – 7,000 S.F.	Lap Lanes and Activity Pool
Regional Family Aquatic Center	15-minute drive	7,000 – 10,000 S.F.	Slide, interactive water play features, party room
Regional Fitness Aquatic Center	15-minute drive	10,000 – 12,000 S.F.	50 meter lap pool, aerobics/program pool
Year-Round Indoor Facility	30 minute drive	Over 10,000 S.F.	Designed for training, competition, and program use

Determination Process



Purpose


- Establish a methodology to rank the suitability of:
 1. existing aquatic facilities;
 2. potential sites for development;
 3. renovation, expansion, consolidation, or decommissioning (closure) of aquatic facilities.

- Will be used as a guide in future decision making on pool status

- Ranking Process
 - Colony Park Site
 - Dove Springs Pool
 - Ramsey Pool

Score out of 100 – Range 42-81
 Score out of 100 – Range 49-71
 Ranking out of 32 sites
 Ranking out of 18 sites
 Ranking out of 9 sites

Score – A higher number = more suitable for renovation, redevelopment or expansion.

Rank – Rank compared to the others, with 1 being the highest/best
