The contract will allow the Austin Convention Center, the Austin Public Library, Austin Water and Communications and Technology Management to have access to Cisco SmartNet Total Care Services, for the City's local and wide area network equipment. Cisco SmartNet Total Care Services will allow City information technology staff access to technical support 24 x 7 on systems that provide essential network services such as interconnections to desktop computers, servers and printers as well as on systems that transmit and receive information via the internet.

Additional services with this Cisco SmartNet Total Care contract will include the "Smart Assist Tool" which will help to identify and manage all of the indicated department's network assets. The City will utilize Smart Assist asset data portal to manage the service coverage and product lifecycles of our assets as well as to easily access and download the security and product alerts that apply to our network assets.

The contracted vendor will provide:

- Hardware installation and system configuration for Cisco Smart Assist service;
- Inventory true up annually based on most recent inventory though the Smart Assist service;
- Accurate system inventory and provide reports every three months through the term of the contract;
- Discount level offered for all equipment added to the contract after initiation; and
- Inventory reconciliation services for equipment identified through Smart Assist that should not be on the contract

This purchase was made through the State of Texas Department of Information Resources (DIR) contract after evaluating and comparing with other contractors on that contract. The selected vendor had best pricing and services.

This contract is replacing a contract with Insight Networking, Inc. The previous contract was for five years at a cost of \$5,059,321. The new contract provides expanded services, including an annual inventory true up.

The State of Texas DIR cooperative establishes competitively bid contracts that can be utilized by the State and other government agencies through a cooperative agreement. Cooperative agreements save taxpayer dollars by leveraging the State's volume-buying power to drive down costs on hundreds of contracts through a streamlined cooperative purchasing program.

Without this continued support, the City will not be able to maintain critical systems essential to City infrastructure.
