Authorize award and execution of a contract with SUPERIOR POWER SOLUTIONS, to purchase a Mitsubishi uninterruptible power supply system, in an amount not to exceed \$79,876.

Amount and Source of Funding

Funding is available in the Fiscal Year 2016-2017 Capital Budget of the Building Services Department.

Fiscal Note A fiscal note is attached. The Purchasing Office issued an Invitation for Bids (IFB) MHJ0204 for these goods on October 10, 2016 and it closed on October 25, 2016 with four offers received. The **Purchasing** recommended offer is the lowest offer submitted by a responsible offeror. Additional Language: information on the solicitation is included below the line. **Prior Council** Action: For More Marty James, Buyer II, 512-974-3164 Information: Boards and Commission Action: **Related Items:** This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement MBE / WBE: Program. For the goods required for this solicitation, there were insufficient subcontracting opportunities; therefore, no subcontracting goals were established.

Additional Backup Information

The contract will provide for the purchase of a new uninterruptible power system (UPS) to replace an existing failing unit at the Rutherford Lane Campus (RLC), Building 4. An UPS is an electrical backup system that runs off of stored energy in batteries to provide power to computers, data centers, telecommunications, and other electronic equipment located in the building in the event of a power failure. The UPS will provide electrical power for a brief time until another power source can be brought online. This UPS will support divisions of the Austin Police Department and Communications and Technology Management housed at RLC.

Services provided under this contract include the proper removal, recycling, and disposal of the old unit and batteries, and delivery, installation, startup, testing, and commissioning of the new UPS System.

If a contract is not secured, RLC will not have a dependable electrical backup system in the event of power failure.
