Dear Mayor Adler and Austin City Council Members:

Edward Rojas, John Foradory, Joe Orosco and Patricia Orosco filed the attached petition for creation of Travis County Emergency Services District No. 15 (the "District"). The District is proposed for the purpose of providing fire prevention and firefighting services in the area. The Commissioners Court of Travis County has accepted the petition and scheduled a public hearing on February 14, 2017, to consider whether to grant the petition and to call an election. Because a portion of the City of Austin's extraterritorial jurisdiction is within the proposed District's boundaries, the City must consent to the inclusion of this area within the District in order for it to be included within the District. (Texas Health & Safety Code §775.014). This letter serves as a formal request that the City consent to creation of the proposed District and allow the District to include the portion of the City's extraterritorial jurisdiction that is within its boundaries.

The petitioners respectfully request to be placed on the City of Austin's agenda as soon as possible under an item titled, "Discuss and consider consenting to the creation of the proposed Travis County Emergency Services District No. 15 and the inclusion of certain extraterritorial jurisdiction within the District, and adopting a resolution on same." While the law allows City action within 60 days, we respectfully request City Council action as soon as possible, but no later than February 13, 2017, so we may report to the Commissioners Court at the public hearing and so we may make the deadline for calling a May 2017 election.

A map of the District and written boundary description are included in the attached petition.

The petitioners respectfully request that you consent to including that portion of the City's extraterritorial jurisdiction in Travis County Emergency Services District No. 15 by adopting a resolution similar to the resolution enclosed and approving the request in writing.

PETITION FOR CREATION OF EMERGENCY SERVICES DISTRICT

TO THE HONORABLE COUNTY JUDGE AND COMMISSIONERS OF THE COURT:

NOW COME 100 or more qualified voters who own taxable real property in Travis County, Texas pursuant to Texas Health & Safety Code, Section 775.011(a), requesting the creation of an overlay Emergency Services District and would respectfully show the following:

I. CREATION AND OPERATION

The proposed new Travis County Emergency Services District ("District") will be created and operated under the provisions of Article III, Section 48-e of the Constitution of Texas and Chapter 775 of the Health & Safety Code ("Code") of the State of Texas.

II. NAME AND NUMBER

The name of the proposed District is "TRAVIS COUNTY EMERGENCY SERVICES DISTRICT NO. 15," which is the next consecutive emergency services district number available in Travis County. See Tex. Health & Safety Code §775.011(b).

III. AREA OF OVERLAY DISTRICT

The area of the new District will overlap Travis County Emergency Services District No. 11, and will generally include the city limits and extraterritorial jurisdiction of the City of Creedmoor and the City of Mustang Ridge that are currently within Travis County Emergency Services District No. 11. Additionally, the area of the new District will include portions of the extraterritorial jurisdictions of the Village of Webberville and the Cities of Austin, Niederwald, Bastrop and Buda, further including the portion of a limited purpose district in the extraterritorial

District No. 11. The boundaries of the District will be coterminous with those of the existing Travis County Emergency Services District No. 11 and are more particularly described by the description attached as Exhibit "A" which is attached hereto and incorporated herein for all purposes, and generally shown on the attached map in Exhibit "B" save and except the city limits or extraterritorial jurisdictions of any cities not identified in this Petition that may overlap the new District. The Petitioners believe they have found and named all the city limits and extraterritorial jurisdictions affected by the new District and to be included in the area of the new District. If any city limits or extraterritorial jurisdictions not specifically named in this Petition are later found to exist within the new District, Petitioners hereby exclude those areas from the new District, as the omission would have been inadvertent.

IV. SERVICES TO BE PROVIDED

The new District will provide the following:

- 1. Fire Prevention and Fire-Fighting Services and related powers and authority, including emergency response on all structure, grass, brush and other fires within the new District on a 24-hour-per-day, seven-day-a-week basis:
- 2. Fire Code adoption and enforcement services within the new District and related powers and authority; and
- 3. All other services and powers that an emergency services district is authorized to provide or exercise under Chapter 775 of the Texas Health & Safety Code, except for first responder emergency medical services and those services and powers related to the provision of emergency medical services, including transport.

The new District will not provide any services that Travis County Emergency Services District No. 11 will continue to provide as set forth in the statement of services to be provided by Travis County Emergency Services District No. 11 in accordance with Section 775.018(g) of the Code.

V. COMPLIANCE WITH CODE

The creation of the new District complies with Section 775,0205 of the Code. (Section 775,020 does not apply to Travis County.) The Petitioners request that the County deliver a copy of this petition to the Board of Commissioners of Travis County Emergency Services District No. 11, and request a statement of services in accordance with Section 775.018(g) of the Code.

VI. PETITIONERS

Four Petitioners present this petition. The Petitioners are: Edward Rojas, who resides at 11401 Tickford Drive, Del Valle, Texas 78617; John Foradory, who resides at 11403 Tickford Drive, Del Valle, Texas 78617; Joe Orosco, who resides at 9028 Elroy Road, Del Valle, Texas 78617; and Patricia Orosco, who resides at 9028 Elroy Road, Del Valle, Texas 78617. Petitioners hereby agree and obligate themselves to pay not more than one hundred fifty dollars (\$150.00) in costs incident to the formation of the new District, including the costs of publishing notices, election costs, and other necessary and incidental expenses, as required by Section 775.013(b) of the Code.

VII. CITIES AFFECTED

The cities of Creedmoor, Mustang Ridge, Austin, Bastrop, Buda, and Niederwald, and the Village of Webberville, are the only municipalities whose consent must be obtained under Section 775.014 of the Code. The portions of the city limits and extraterritorial jurisdictions of the cities of Creedmoor and Mustang Ridge that are currently within Travis County Emergency Services District No. 11 will be within the territory of the new District. The portions of the extraterritorial jurisdictions of the Cities of Austin, Bastrop, Buda (including a portion of a limited purpose district in Buda's ETJ) and Niederwald, and the Village of Webberville that are currently within the boundaries of Travis County Emergency Services District No. 11 will be within the territory of the new District.

VIII. SIGNATURES REQUIRED

The signatures required by Section 775.011(a) of the Code for the creation of the District are attached hereto as Exhibit "C" and are incorporated herein by reference.

WHEREFORE, PREMISES CONSIDERED, Petitioners pray that such notices be issued by the County Clerk of Travis County as required by law; that a public hearing be held on this petition in the county; that a copy of this petition be sent to Travis County Emergency Services District No. 11 together with a request for a statement of services; and, that after the hearing the Commissioners Court of Travis County grant this petition and call a special election regarding the creation of the new District.



WHEREAS, the City of Austin, Texas ("City"), has received the petition attached as **Exhibit "A"**, and a letter requesting the City's consent to the creation of an emergency services district ("District"), proposed to be known as Travis County Emergency Services District No. 15, which includes a portion of the extraterritorial jurisdiction of the City within Travis County, and

WHEREAS, the City desires to grant its written consent to the creation of the District; and

WHEREAS, the City desires to grant its written consent to the inclusion of its extraterritorial jurisdiction that is within the proposed District.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, that the City gives its written consent to the creation of the District, proposed to be known as Travis County Emergency Services District No. 15, and to the inclusion of the extraterritorial jurisdiction of the City that is within the boundaries of the District as more particularly described in the petition attached as **Exhibit A**. This consent is valid for a period of six months from the date of its adoption.




Exhibit C: Background

Travis County ESD #15 Review of Potential Impact to City of Austin



Impact to City of Austin:

- The proposed TC ESD #15 does not overlap with COA full-purpose, but according to the GIS layer, it does overlap slightly with COA's ETJ and limited purpose.
- This will not impact service delivery for AFD since AFD is responsible for COA full-purpose jurisdiction and not ETJ or limited purpose. Service delivery to non-full-purpose COA areas in SE Travis County is under ESD 11's responsibility.
- Since this agreement is for fire prevention and firefighting only (IV. Services to Be Provided, item 1), it will not impact A/TCEMS's ability to provide service.

Background:

- Over 100 qualified Travis County voters are seeking the creation of an overlapping ESD to provide fire prevention and firefighting services in a portion of SE Travis County.
- ESD 15 will overlap the existing ESD 11 boundary in SE Travis County.
- Currently, the area is provided firefighting services primarily by ESD 11, and thru an Auto Aid Agreement with AFD.
- The Auto Aid agreement between AFD and ESD 11 provides "closest unit response" to both ESD 11 and City of Austin (full purpose) jurisdiction. This results in ESD 11 units responding into COA full-purpose and AFD responding into ESD 11 territory to provide firefighting services to residents.
- A/TCEMS provides emergency medical services to ESD 11 residents, including transport to the hospital.
