PROPOSAL

Construct a two-story addition to the rear of the existing house; construct a two-story garage apartment.

PROJECT SPECIFICATIONS

The proposed addition will add 371 square feet to the ground level of the house and will have 674 square feet upstairs. The proposed garage apartment will have 511 square feet. Construction of the addition will require the removal of a portion of the existing roof, walls, and partitions.

The proposed addition will have horizontal wood siding and wood trim, and a hipped roof with composition shingles. Windows in the addition will be single-hung and painted. The addition will be located at the existing side gable on the historic house. The proposed garage apartment will have horizontal wood siding and a hipped roof with composition shingles. Windows in the garage apartment will also be single-hung and painted.

STANDARDS FOR REVIEW

The Willow-Spence National Register Historic District has no specific design guidelines for additions to historic buildings. The design guidelines for the district are found within the East Cesar Chavez Neighborhood Plan, and were adopted in June, 2000; these mostly address new construction.

General design principles for historic districts recommend retaining the façade of a historic building, and designing the addition so that it does not compete with the historic building in terms of size, scale, materials, fenestration patterns, and massing. General design principles recommend a single-story rear addition to a single-story house whenever possible, but where the addition must be two stories, setting the addition back from the front of the house at a distance sufficient to retain the character and articulation of the street façade.

STAFF NOTE

The East Austin Historical Survey (2016) determined that this house is eligible for individual designation; staff's research on the history of this house is attached.

STAFF RECOMMENDATION

The addition, while large, comports with applicable design principles in that it is set back from the front of the house (behind the ridgeline of the side-facing gable), and uses materials compatible with the historic character of the house and the district. The proposed garage apartment also complies with all applicable design principles.

Staff recommends approval of the proposal with the following conditions: retain and preserve the existing window in the front gable of the house; it is not clear from the plans that this window will be preserved; and complete a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, prior to the release of any permits.

BIOGRAPHICAL NOTES:

Ross L. and Eula Hill (ca. 1910 – ca. 1912)

The 1910 U.S. Census shows Ross and Eula Hill as renters at this address. Ross Hill was 19, had been born in Texas, and was a brakeman for the railroad. Eula Hill was 17, had been born

in Texas, and had no occupation listed. The census report also shows Thomas F. and Eula Keating at this address. Thomas F. Keating was 30, had been born in Alabama, and was a druggist at a drug store. Eula Keating was 24, had been born in Texas, and had no occupation listed. They had a daughter, Roshell, 10 months. The Keatings were also renters at this address.

The 1900 U.S. Census shows Ross Hill as the 10-year old son of Miles H. and Mary Hill of Elgin, Texas. Ross' next older sister was Eula Hill, who was 14. It is believed that Eula Hill married Thomas Keating, and lived in this house with Ross Hill and his wife, also named Eula. Both Ross and Eula Hill are listed as at school. Their father was a lawyer.

William D. and Beulah Craig (ca. 1912 – ca. 1919)

The 1910 U.S. Census shows W.D. and Beulah Craig living in Granger, Texas. W.D. Craig was 33, had been born in Texas, and was a pharmacist. Beulah Craig was 24, had been born in Texas and had no occupation listed. They had a son, W.D., Jr., 1, and an infant daughter whose name is not listed in the census report. Both children had been born in Texas.

The 1920 U.S. Census shows the Craigs living at 1009 E. 1st Street in Austin; they owned that house. William D. Craig was 43, had been born in Texas, and was a druggist. Beulah Craig was 33, had been born in Texas, and had no occupation listed. Their children were William D., 11; and Dorothy, 9. Both had been born in Texas. The 1930 U.S. Census shows the Craig family at their home at 1009 E. 1st Street; the house was worth \$3,000. William D. Craig was a druggist. Both of their children still lived with them, but neither had an occupation shown in the census report. In 1940, according to the census report of that year, William D. and Beulah Craig were still living at 1009 E. 1st Street; William D. Craig was a 63-year old druggist. Dorothy Craig was not listed with them any more, but William D. Craig, Jr., a 31-year old book-keeper at the State Board of Control is listed with his parents.

The 1930 U.S. Census shows Emma Sunden as the owner of this house, which was worth \$3,500. She was a 68-year old Swedish-born widow with no occupation listed. With her lived 4 adult children: Eric, 35, a mechanic in an auto shop; Alma, 33, who had no occupation listed; Elmer, 25, a tinner; and Arthur, 22, a laborer for a private firm. All of Emma Sunden's children had been born in Texas.

The 1940 U.S. Census shows Elmer J. and Pauline Sunden as the owners of this house, which was worth \$3,500. Elmer J. Sunden was 34, had been born in Texas, and was a tinner. Pauline Sunden was 24, had been born in Texas, and was the receiver for a department store. With them lived Annie M. Didway, 16, who had been born in Texas, and had no occupation listed..

The 1940 U.S. Census shows Chester R. and Lottie Puckett renting the house at 67 Waller Street in Austin. Chester Puckett was 36, had been born in Texas, and was a truck driver for the city. Lottie Puckett was 37, had been born in Texas and had no occupation listed. They had 2 children: Raymond, 13; and Fay, 6. Both had been born in Texas. Also in the household was Lottie Puckett's mother, Hattie Cooper, a 59-year old Tennessee-born widow with no occupation listed.

His 1977 death certificate shows that Chester Raymond Puckett was born in 1904 in Travis County, and was a general foreman for the Street and Bridge Department of the City of Austin. He was living at 1311 Fairwood Road at the time of his death.


