Thompson, and L. O'Donnell. In review. Density and nest survival of golden-cheeked warblers varies with plot, forest, and landscape characteristics.  Two more manuscripts will be submitted in 2017.	
	On December 15, 2016, the U.S. Fish and Wildlife Service published a 12-month finding/proposed rule to delist the Black-capped Vireo, with a 60-day public comment period. Staff prepared comments on the proposed delisting.

Habitat Restoration	Staff and volunteers are continuing to implement demonstration projects at the Vireo Preserve to promote slope stabilization, soil restoration, and regeneration of native plants on degraded areas that are currently not habitat for either the GCWA or BCVI. Staff completed a gazebo roof and rainwater collection systems, and began a native plant nursery. Since Vireo Preserve supports many of the habitat types observed throughout the BCP, lessons learned from restoration work at this site should be applicable to other areas within the BCP.	
Fencing	Installed 1,080 linear feet of fencing along the southern boundary of Forest Ridge, along Lakewood Drive	
Wildfire Preparedness	Shaded fuel break work was completed on Double J and T including 780 linear feet (1.1acres) in the Gebron area and 1,450 linear feet (1.7 acres) in Apache Shores. We began a research project to survey vegetation before and after treatment, including species composition and material, volume removed, and canopy density.	
Law Enforcement		
Trespass and Criminal Mischief	In December 2016 the chain locking the fence around Midnight Cave was cut on 2 occasions. No damage to the cave was observed. On January 7, 2016 a security camera was installed which observed 4 individuals inside the enclosed area later that evening. The 4 persons were apprehended but released on warning after identification. A new security gate lock was installed and no further trespassing has been observed.
