REGULAR MEETING  
MONDAY, JUNE 15, 2015

The Regional Affordability Committee convened in a regular meeting on Monday, June 15<sup>th</sup>, 2015 in the Boards and Commissions Room at City Hall, 301 W. 2<sup>nd</sup> Street in Austin, Texas.

Vice Chair Paul Saldana called the Committee Meeting to order at 3:09 p.m.

### APPROVAL OF MINUTES

### STAFF BRIEFINGS

- Presentation on the findings of the 6th annual Community Advancement Network (CAN) Dashboard Report.**

Mary Dodd, interim Executive Director, presented on the findings of the 6<sup>th</sup> annual Community Advancement Network Dashboard Report. Ms. Dodd and her staff then answered questions from Committee Members.

- Presentation by Conversation Corps related to the July Conversation Corps meeting on housing affordability.**

Larry Schooler, Community Engagement Division Manager, City of Austin, presented on the Conversation Corps mission and goals, including an overview of the program and the work plan for the upcoming months. Mr. Schooler invited all committee members to attend the July session. He then answered questions from the committee members.

Chair Saldana suggested taking up all three items listed for discussion at once, with no objections. Dr. Coopwood suggested the Committee define what they mean by "affordability," and that members should decide which areas to focus on. Committee members discussed the need to create an action plan around their affordability goals, as well as how the different taxing entities could participate together to address the affordable housing issues. Committee members discussed sharing lists of underutilized properties and Interlocal agreements with all entities to leverage any available opportunities therein.

#### **FUTURE ITEMS**

- 1. Discussion of future agenda items.**

Chair Saldana suggested that the August meeting of the Regional Affordable Committee focus on only the affordable housing conversation and the Committee's strategic plan, while the Meeting in September would continue the discussion on the strategic plan with a comprehensive discussion about Interlocal opportunities.
