

M/WBE Summary

Public notice was given for this solicitation, CLMC608 ADA Sidewalk and Ramp Improvements 2016-2018 Quarter Cent Projects South, Districts 2, 5, 8 - IDIQ, through the City's Vendor Connection web portal which resulted in 460 contractors receiving notification. Sixty-three contractors obtained the bid documents and three bids were received and opened on January 12, 2017. One out of three bids received was from MBE/WBE certified firm. Muniz Concrete & Contracting, Inc. submitted the lowest responsive bid:
