1. CALL TO ORDER

a. Chair Michael Jones called the meeting to order at 6:06 p.m.

2. CITIZEN COMMUNICATION: GENERAL

- a. Dusty Harshman addressed the Commission as an AISD Facilities and Bond Planning Advisory Committee (FABPAC) member and provided a brief update on FABPAC's current work and the AISD Facilities Master Plan.
- b. Ani Colt, with Prestyon Tyree donating time, addressed the Commission regarding creating a more friendly bicycle and tricycle community at Mueller.
- c. Rob Corbett declined to address the Commission.

3. OLD BUSINESS

a. <u>Proposed Affordable Multi-Family Housing:</u> After discussion about Mueller's affordable housing goals and requirements, Commissioners approved a resolution of support to Council for Foundation Communities proposed affordable multi-family housing development at Mueller and tax credit application, on Commissioner Krivoniak's motion and Commissioner Drennan's second on a 7-0 vote.

a. <u>Mueller Illustrative Plan and Program Update:</u> Jim Adams with McCann Adams Studio and Dee Desjardin with Catellus provided an overview of the updated Mueller Illustrative Plan and highlighted changes to the plan over time, as well as provided an update on the residential and commercial development program.

b. <u>Mueller Development Update</u>: Dee Desjardin provided a brief update on 1) a recent AISD Board Meeting and 2) infrastructure construction status, including the opening of Aldrich Street and other Town Center streets.
