### 1. CITIZEN COMMUNICATION: GENERAL

The first 15 speakers signed up prior to the meeting being called to order will each be allowed a three-minute allotment to address their concerns regarding items posted or not posted on the agenda.

- 1. Debbie Russell Pecan Street Festival Association. Provided brief history of the Pecan Street Festival (largest arts and music festival in the state) \$43 million economic impact in 2008, 30% of the attendees are from out of town.
- 2. Julie Mech Austin Creative Alliance. Presentation of draft letter sharing the budgetary priorities of the Austin Creative Alliance.
- 3. Speaking on Agenda item 4.b. Zach Treager Founder and Director of MoHA. Highlight of lack of focus in CodeNEXT on creative space. Proposes the creation of a Joint Music and Arts Sub Commission on land use code.
- 4. Speaking on Agenda item 4.b. Brad Carlin, Managing Director of Fuse Box Austin. Concern on the window of time available to address the code updates and feedback. Continue to ask for support and help and feedback from the arts community. Where does the arts community need to show up and provide support, what are the holes that aren't being covered
- 5. Speaking on Agenda item 4.b. Dave Sullivan on CodeNEXT Advisory Group Looking at the first draft. Remember there will be two more drafts it will be May or June of 2018 when the final draft will be ready. Sections 23.2 & 23.3 are important to areas to focus on the code.
- 6. Speaking on Agenda item 4.b. Madge Darlington Co-Producing Artistic Director Rude Mechs. The Off Center is closing in 45 days. What is the process to access potential underutilized city facilities that could be used? Theatre in the code is referring to Movie Theatres, there should be a specific definition of theatrical live performance venues.
