 - **Public Safety/Commissioner Karen Crawford:** Texas Here to Stay continues to conduct "Know your Rights" sessions with 150-200 immigrants participating. "People are scared." According to San Antonio area ICE fact sheet reports that 51 immigrants were arrested and of those 23 of whom criminal convictions and arrested in Austin, Texas. Grass Root Leadership set up a Hotline: 512-270-1515 for anyone effected by a raid in Austin.
 - Children in Schools: Commissioner Krystal Gomez Commission to request Ride Austin to offer a free ride for parents dropping off children at schools during ICE raids at schools - "coupon code". Vice-Chair Alba Sereno motioned to approve. Commissioner Nicole Merritt seconded. Approved on a 10-0 vote with Commissioner Rosalia Austin absent. Immigrant Services Network of Austin offering A Family Planning Tool Kit was developed to help prepare immigrants and their families in case of deportation.
 - **Civic Engagement:** Link City of Austin International Welcome website and face book. Vice Chair Alba Sereno will explore information about funding resources for immigrant families in case of deportation. Commissioner Piper Nelson motioned to approve. Commissioner Krystal Gomez seconded. Approved on a 9-1 vote with Commissioner David Vandenberg against and Commissioner Rosalia Austin absent.
