2014 E. 9TH STREET

PROPOSAL

Demolish a ca. 1917 house.

ARCHITECTURE

One-story, rectangular-plan, hipped-roof frame house with a partial-width inset porch; single 1:1 fenestration; addition of unknown vintage on the rear; breezeway connects the house to a former beauty salon and auxiliary dwelling on Mill Street (902 and 904 Mill Street).

RESEARCH

The house was built around 1917 by Monroe and Maude Estelle Taylor, who lived here until around 1960. Monroe Taylor is listed as the owner of this house throughout the city directories. He grew up on a farm in rural Travis County and worked as a farm laborer in his early years. After he married and moved into Austin, he is listed as a laborer in the city directories; the 1920 U.S. Census confirms that he was a laborer doing general work. Around 1923, he got a job as a laborer for Calcasieu Lumber Company, an employment relationship he maintained for the rest of his working life. He worked as a loader, a truck driver, and as a yard man for Calcasieu, Austin's largest lumber company at the time. His wife, Estelle, worked as a maid, but also ran a beauty salon, first in the house, and then in an auxiliary building on the property, connected to the back of this house via a breezeway. The Taylors had 9 children, and one, Monroe Taylor, Jr., occupied a small house on the back of this property, with an address of 904 Mill Street, for several years in the late 1940s.

Apparently, Monroe and Estelle Taylor quit living together in the early 1950s. he continued to live in this house, while Estelle Taylor moved to a house at 2008 E. 8th Street, which is up for landmark designation by the Historic Landmark Commission. Estelle Taylor continued to work as a maid, and shared her home on E. 8th Street with her daughter, Ora Lee, who was married to Spencer Nobles, Jr. Ora Lee Nobles has a long and distinguished history in East Austin, but that is the subject of the landmark designation for the 8th Street house.

Monroe Taylor passed away in 1959, while still living in this house, while Estelle Taylor had moved to 8th Street. After his death, his daughter, Julia F. Mitchell is listed as the owner and occupant of the house through the early 1990s. Julia Mitchell (also known briefly as Julia Chatman after her marriage to Leonard Chatman), was a maid and food server at her sister and brother-in-law's restaurant, the Rosewood Barbecue Center on Rosewood Avenue.

STAFF COMMENTS

The East Austin Historic Survey (2016) notes that the exterior wall materials, windows, and doors have been replaced, and recommends that this house is not eligible for local or national designation.

STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for

archiving at the Austin History Center. This house does not have the same historical significance as the house on E. 8th Street that members of this family also owned, and does not possess the architectural integrity or significance to warrant individual designation as a local landmark.



BIOGRAPHICAL NOTES:**Monroe and Maude Estelle Taylor (ca. 1917 – ca. 1959)**

The 1910 U.S. Census shows Monroe Taylor as the 20-year old son of Grant and Lennie Taylor of Justice Precinct 6 in Travis County. Monroe was the oldest of the couple's 4 children, all sons, listed in the census report. Both Monroe's parents had been born in Texas. His father was a farmer; everyone else in the family was a farm laborer.

The 1920 U.S. Census shows Monroe and Estell Taylor as the owners of this house. Monroe Taylor was 32, had been born in Texas, and was a laborer doing general work. Estelle Taylor was 24, had been born in Texas, and had no occupation listed. They had 4 children: Vernon, 6; Linna May, 4; Ardie, 2; and Margerie, 2 months.

The 1930 U.S. Census shows Monroe and M. Estell Taylor as the owners of this house, which was worth \$900. Monroe Taylor was 39, had been born in Texas, and was a yard hand in a lumber yard. M. Estell Taylor was 34, had been born in Texas, and had no occupation listed. They had 9 children: Vernon, 16; Linnie, 14; Ardie, 13; Marjorie, 9; Ora L., 10; Monroe, Jr., 6; Mattie, 4; William, 2; and Jessie A., 3 months. All of the children had been born in Texas.

MONROE J. TAYLOR

Funeral services were pending Thursday night at Phillips-Upshaw Funeral Home for Monroe J. Taylor, 70, of 2014 East Ninth Street, who died Thursday morning in a local hospital.

Arrangements were being delayed pending the arrival of a son from Philadelphia.

Taylor had been in ill health for the past two years. He was a former truck driver and yard foreman at the Calcasieu Lumber Company, where he was employed for about 39 years.

He was a charter member and deacon of Pilgrim Rest Primitive Baptist Church and a member of the American Woodman Lodge.

Funeral services for Mrs. Maud Estell Taylor will be held Thursday at 3 p.m. from Pilgrim Rest Baptist Church with Rev. B. J. Woods officiating. Burial at Evergreen Cemetery will be under direction of Phillips and Upshaw Funeral Home.

Survivors include four sons, Vernon O. Taylor of Pennsylvania, William T. Taylor of San Antonio, Roger Lavon and Monroe Taylor, Jr. of Austin; six daughters, Mrs. Ardie McFord, Mrs. Marjorie Batty, Mrs. Julia Mitchell, Mrs. Ora L. Nobles, Mrs. Mattie Joyce Perkins and Miss Helen Marie Taylor, all of Austin; 28 grandchildren and 11 great - grandchildren.
