The City Code requires you to recuse yourself when you have a "substantial interest" that would be affected by a vote of the board on which you serve. Under state law, you have a substantial interest in a business entity if: You own 10% or more of the voting stock or shares of the entity You own 10% or more or \$15,000 or more of the fair market value of the entity. You received funds from the business entity that exceed 10% of your gross income for the previous year. State law considers your interests to be the same as someone related to you in the first degree by blood or marriage. The City Code extends this group of relatives to the second degree. Relatives in the second degree include you and your spouse's siblings, parents, grandparents, children, grandchildren, and the spouses of these relatives. If any one of these relatives has a substantial interest, you are considered to have that same interest. 	decision? Do I have a close personal or financial relationship with an interested party that isn't covered by city or state recusal requirements? Have I received a gift or hospitality from anyone who stands to gain or lose from this decision? Will this affect my future employment opportunities? How would I feel if I saw a story about my connection with this issue on the news or read about it in the paper? Would I be embarrassed if people found out about my personal connection to this issue? If you feel that you cannot cast a well-informed vote based upon the information you have in your possession, if you can't separate your personal feelings from a decision, or you think the public would think your relationship to a particular issue is suspect—abstain.
