2. CITIZEN COMMUNICATION

- Doug Ballew: Request to install a 2-way cycle track through Givens Park connecting E.12th St. and Oak Springs. Currently the park road is one-way southbound between Givens Recreation Center and Oak Springs. For cyclists heading connecting Springdale to E. 12th St., this is a route that avoids a hill and traffic light at the intersection of Springdale and E. 12th St.

3. REVIEW AND APPROVAL OF FEBRUARY MEETING MINUTES

4. ITEMS FROM BAC

A. Youth Mountain Bike Trail in/near Central/South East Austin – Discussion and Possible Action

Laura Pierce Carbonneau and Kent Browning presented draft recommendation language to the BAC for consideration and answered BAC member questions regarding their proposal.

Action taken: A motion to approve the recommendation language below passed unanimously (8-0):

“NOW, THEREFORE, BE IT RESOLVED that the Bicycle Advisory Council supports the efforts of Austin Ridge Riders and partners to develop more beginner Mountain Bike trails in or near the core/central east Austin (including but not necessarily limited to Country Club Creek greenbelt, Roy Guerrero Park, and along the Southern Walnut Creek trail) and asks the Parks and Recreation Department to expedite such projects in collaboration with any other City department or program.”

B. Travis County Transportation Plan – Briefing

D. Austin Independent School District (AISD) Facility Master Plan and Sustainability Plan Recommendation – Discussion and Possible Action

Kathryn Flowers, Sophia Benner and Tom Wald presented draft recommendation language for the BAC's consideration.

Action taken: After debate and amendment, a motion to approve the recommendation language below passed unanimously (8-0) on Tom Wald motion and Mike Sledge second:

“NOW, THEREFORE, BE IT RESOLVED that the Bicycle Advisory Council recommends that the AISD Facilities Master Plan includes the following:

- Recommendation that the front/main access to all new schools constructed be located on streets with a posted speed limit below 35 mph, preferably with the traffic volumes of a local street.

- Recommendation that all school properties be designed with pedestrian and bicyclist access in mind and ensure a safe, reliable, and easily accessible ingress and egress from the street to bicycle parking and campus destinations, especially during peak periods.
- Special attention should be paid to the effect or impact of drop-off and pickup queuing on bicycle facilities.
- Recommendation that all schools be required to provide at least the minimum amount of bicycle parking to ensure that there is enough bicycle parking to meet the current and future demand.
- Recommendation that AISD coordinate with local transportation jurisdictions to include active transportation facilities and connectivity approaching schools for all ages and abilities.”
