- 1. Chair Hohengarten called the meeting to order at 6:00 p.m.
- 2. Presentation by Sabina Romero and Maura Newell of the City of Austin Innovation Office on the Resolution to support the co-location of the HOST Team at the 1213 Sabine Street building. Power Point presentation made. Discussion ensued. Motion postponed to next meeting of Board of Directors on May 10<sup>th</sup>.
- 3. Approval of the minutes from the March 8, 2017 Austin/Travis County Sobriety Center Board meeting.

<u>Motion:</u> Director Brice made a motion to approve the minutes as presented. <u>Second:</u> Director Gomez. <u>Vote:</u> The board voted unanimously in favor of the motion.

6. Discussion of the proposed budget for FY18. Discussion and suggested amendments.

<u>Motion:</u> Director Hohengarten made the motion to add to the budget at the discretion of the Interim Executive Director funds to maintain the facility based on input from Travis County and to account for the depreciation of assets. <u>Second:</u> Director Moore. <u>Vote:</u> Unanimous with one abstention (Director Toyo)

<u>Motion:</u> Director Ortega made a motion to add \$5,000 to the budgeted amount for the CPA and subtract \$5,000 from the amount budgeted for Legal. <u>Second:</u> Strakowski. <u>Vote:</u> Unanimous with one abstention (Director Tovo)

<u>Motion:</u> Director Strakowski made a motion to use the City's rates for benefits, including retirement for employees at Supervisor level and above. <u>Second:</u> Ziebell. <u>Vote:</u> Unanimous with one abstention (Director Tovo)

<u>Motion:</u> Director Ziebell made a motion to approve the amended budget. <u>Second:</u> Strakowski. <u>Vote:</u> Unanimous with one abstention (Director Tovo)

7. Discussion of Search committee status.

<u>Motion:</u> Director Brice made a motion to allow the search committee to negotiate a contract with a search consultant and to bring it to the board for final approval. <u>Second:</u> Director Ziebell. <u>Vote:</u> Nearly unanimous (Director Brown against) and one abstention (Director Gomez).
