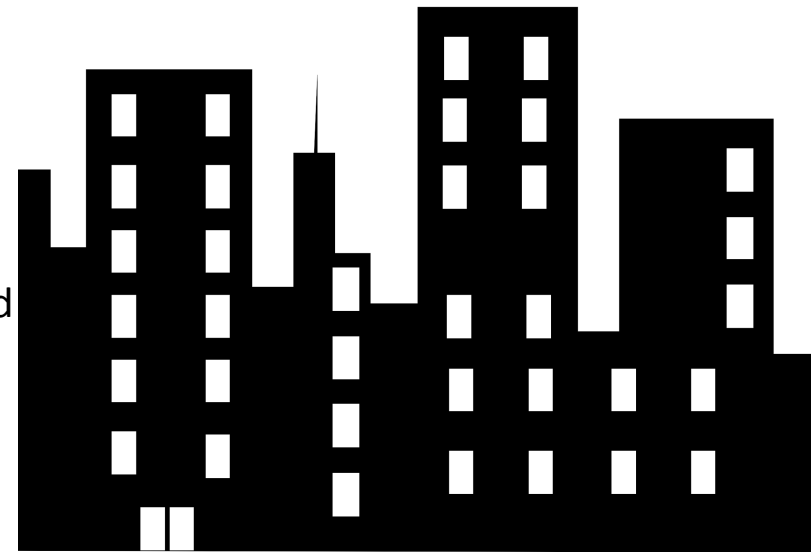
Revenue Caps

S.B. 2 (Bettencourt):

- Passed the Senate, March 21
- Senate amended the cap from 4% to 5%
(\$24 less for Austin homeowner in property taxes
and \$11.4 million less for City)
- Reported as substituted from House
Ways & Means , May 15

H.B. 15 (Bonnen):

- Bill was referred to House Ways & Means but not heard



Sanctuary Cities

S.B. 4 (Perry) –

- Passed the Senate, February 8
- Vote: 20 aye, 10 nay
- Passed the House, April 27
- Vote: 94 aye, 53 nay,
1 PNV (Speaker Straus)
- Signed by the Governor, May 7



Bathroom Bill

S.B. 6 (Kolkhorst) –

- Passed the Senate and sent to House March 16
- Awaiting House Committee Referral

H.B. 2899 (Simmons)

- Bill did not make it out of committee by deadline



Transportation Network Companies (TNCs)

H.B. 100 (Paddie) –

- Passed the House, April 20
- Vote: 110 aye, 35 nay
- Received in the Senate, April 24
- Placed on Senate Intent Calendar for first time, May 16



S.B. 361 (Nichols) –

- Reported Favorably out of Business and Commerce committee, March 22



Short Term Rentals (STRs)

S.B. 451 (Hancock) –

- Passed the Senate, April 18
- Vote: 21 aye, 10 nay
- Received in the House, April 19
- Referred to House Urban Affairs, May 9

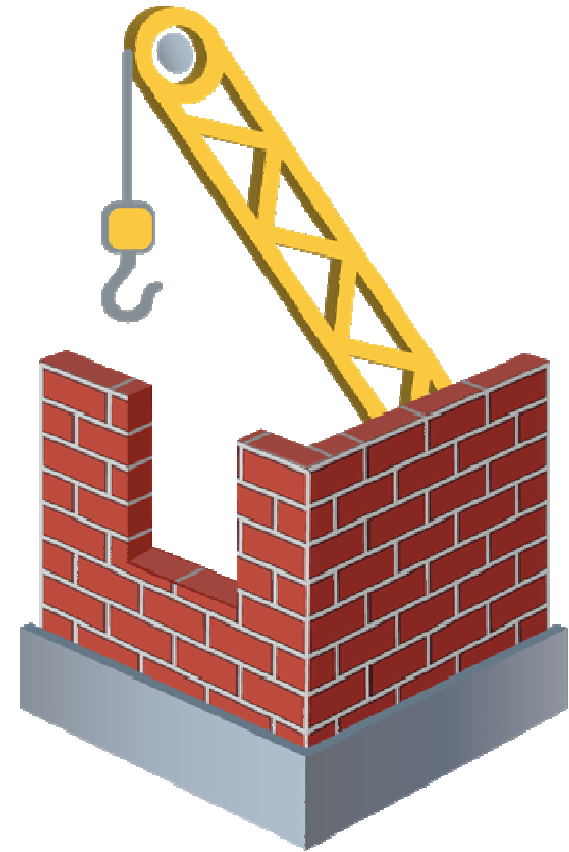

- Bill is pending

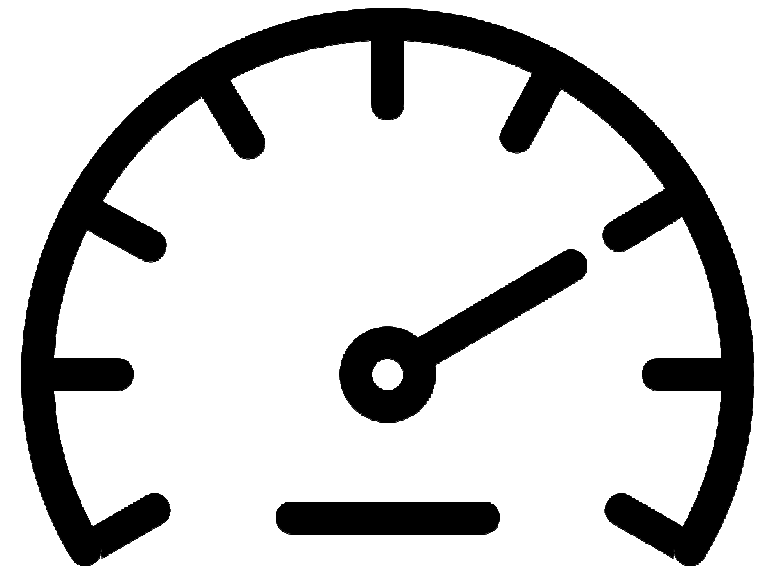

- Bill was not placed on Calendar by deadline

S.B. 1 (Estes) –

- Passed the Senate, March 28
- Vote: 31 aye, 0 nay
- Passed the House, April 7
- Vote: 131 aye, 16 nay
- Conference committee set, April 24
- Senate Conferees: Nelson (Chair), Hinojosa, Huffman, Kolkhorst, Schwertner
- House Conferees: Zerwas (Chair), Ashby, Sarah Davis, Gonzales, Longoria

May 20 – Last day for House Committees to report SBs/SJR out of committee.

May 24 – Last day for Senate to consider all bills.

May 26 – Last day for House to act on Senate amendments.

May 28 – Last day for House / Senate to concur in amendments or adopt CCRs.

May 29 – Last day of Session.
