Community Services Block Grant Programmatic/Financial Report June 13, 2017

The Community Services Block Grant funds the delivery of services to low income Texas residents in all 254 counties. These funds support a variety of direct services in addition to helping maintain the core administrative elements of community action agencies.

For the City of Austin, the grant provides funding for the delivery of basic needs, case management, preventive health and employment support services through the City's six (6) Neighborhood Centers and the three (3) Outreach Sites.

- Basic Needs (food, clothing, information and referral, notary services, transportation, school supplies, car safety education and car seats, tax preparation, Blue Santa applications, fans, Thanksgiving food baskets and other seasonal activities);
- **Preventive Health** (screenings for blood pressure, blood sugar, and cholesterol; pregnancy testing; health promotion presentations, coordination and participation in health fairs, immunizations, coordination of wellness activities, linkages to medical home providers);
- Case Management (individual/family support counseling, advocacy, self-sufficiency case management, crisis intervention, linkages with employers, educational opportunities and training, and working with individuals on quality of life issues);
- **Employment Support** (intake, assessment and goal setting, job readiness training, job placement assistance, and job retention services)

- <u>CSBG Budget -</u> The President's initial 2018 budget eliminates funding for the Community Services Block Grant. CSBG currently supports 16 of the 35 staff positions at the Neighborhood Centers, along with rent and utility assistance.
- CDC By-laws The CDC's recommended updates were submitted and the City Clerk's
 office has now indicated the item will be on the City Council's Audit and Finance
 Committee's agenda on June 21, 2017.
- 3. <u>Pre-Juneteenth Education and Wellness Fair</u> The Blackland Neighborhood Center will be hosting this event again this year on June 16, 2017 from 10 am to 2 pm. We hope you can join us.
- 4. <u>Income Tax Assistance</u> Through the AARP Income Tax Assistance program offered at the Rosewood-Zaragosa Neighborhood Center, this year, 116 taxpayers received a total of \$133,687 in income tax credits. We will be reporting this information as part of our May performance report to TDHCA.
- 5. Story of Success A woman in her late 60s came into the South Austin Neighborhood Center seeking assistance. She explained to staff that she was living on a fixed income from the VA and had gotten behind on her rent due to unexpected medical expenses. She had received an eviction notice and didn't know how she would be able to pay the back rent and fees she owed. Through working with the staff at South Austin, they were able to reduce the amount owed, and help the client connect to resources that would assist her in paying off the debt through a local program. The client was able to avoid eviction and maintain her housing as a result.
