

**ORDINANCE NO. 20170615-059**

**AN ORDINANCE AMENDING CITY CODE SECTION 12-4-64(D) TO ESTABLISH A MAXIMUM SPEED LIMIT OF 45 MILES PER HOUR ON A SECTION OF EAST SLAUGHTER LANE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** City Code Section 12-4-64(D) (*Table of Speed Limits*) is amended to add:

Slaughter Lane (East) from 1,500 feet east of I.H. 35 East Frontage Road to Brandt Road/City Limit. (45 MPH Speed Limit)

**PART 2.** The amendments made in this ordinance are based on the results of a traffic engineering investigation, or "speed study," attached as Exhibit "A".

**PART 3.** The amendments made in this ordinance shall be incorporated in alphabetical order and the existing entries reordered accordingly.

**PART 4.** This ordinance takes effect on June 26, 2017.






A Traffic Engineering Investigation has been conducted by the Traffic Engineering Division to determine the appropriate speed limit on E. Slaughter Lane from 1,500 feet east of I.H. 35 East Frontage Road to Brandt Road/City Limit. A speed limit of 55 miles per hour (MPH) was previously established in 2003.

**Location Conditions:**

E. Slaughter Lane is a six-lane major arterial roadway with turn bays and a center median that generally runs in an east-west direction but turns north-south near the study area. Adjacent land use has changed extensively in the past several years with the construction of single family neighborhoods, apartment complexes and retail development.

Figure 1 represents a map of the study area. Currently, the section of E. Slaughter Lane from I.H.35 to Brandt Road is under the jurisdiction of the City of Austin. E. Slaughter Lane, east of Brandt Road, is the under jurisdiction of Travis County.

**Speed and Volume Data:**

A speed study was conducted in accordance with the Texas Procedures for Establishing Speed Zones. Speed and volume data were collected in January 2017 to determine the appropriate posted speed limit for E. Slaughter Lane from 1,500 feet east of I-35 to Brandt Road. An average of over 20,000 vehicles per day was recorded on E. Slaughter Lane from I.H. 35 East Frontage Road to Brandt Road/City Limit. As summarized in Table 1, the 85<sup>th</sup> percentile speed on the eastbound and westbound lanes was recorded in the range of 50 mph to 52 mph.

**Crash Data:**

Austin Police Department's crash database was reviewed to analyze all documented crashes on the study segment within the previous two years. Seven crashes were documented during this period; no discernible pattern from excessive speed is present.



Figure 2 presents a map of the study area and the existing speed limits. Currently the speed limit is 45 mph for eastbound traffic from IH-35 to approximately 1,500 feet east of IH-35. From 1,500 feet east of IH-35 to Brandt Road the speed limit increases to 55 mph. At Brandt Road where E. Slaughter Lane enters Travis County jurisdiction, the speed limit decreases to 50 mph. In the westbound direction, the speed limit is set at 55 mph from Brandt Road to 1,500 feet east of the IH-35 East Frontage Road where it decreases to 45 mph.

Figure 3 presents a map of the proposed speed limit based on the collected data and analysis. The Austin Transportation Department recommends adjusting the speed limit of approximately 3,000 feet of E. Slaughter Lane to 45 mph based on the recent speed data. This will also set a consistent speed limit for the segment of E. Slaughter Lane under the City of Austin jurisdiction.

**Figure 2. Existing Speed Zone Map**



**General Comments:**

A Traffic Engineering Investigation has been conducted by the Traffic Engineering Division to determine the appropriate speed limit on E. Slaughter Lane from 1,500 feet east of I.H. 35 East Frontage Road to Brandt Road/City Limit. A speed limit of 55 miles per hour (MPH) was previously established in 2003.

Based on the change in adjacent land use with multiple access points for residential and retail development along this section of E. Slaughter Lane, it is recommended to change the speed limit to 45 mph for approximate one half mile section from 1,500 feet east of IH-35 East Frontage Road to Brandt Road. This will also allow for a consistent speed limit of 45 mph for the section of E. Slaughter Lane east of IH-35 under the jurisdiction of the City of Austin.

Based on the analysis of this information, it is my engineering judgement that the speed limit on East Slaughter Lane should be 45 miles per hour from 1500 feet east of I.H. 35 East Frontage Road to Brandt Road/City limits.
