6 **AN ORDINANCE ACCEPTING GRANT FUNDS FROM THE TEXAS**  
7 **DEPARTMENT OF PUBLIC SAFETY AND AMENDING THE FISCAL YEAR**  
8 **2016-2017 OPERATING BUDGET SPECIAL REVENUE FUND (ORDINANCE**  
9 **NO. 20160914-001) TO APPROPRIATE THESE FUNDS FOR REPAIRS TO CITY**  
10 **FACILITIES AND REPLACEMENT OF CITY PROPERTY DAMAGED OR**  
11 **DESTROYED BY THE FLOODING OF MAY AND OCTOBER 2015; AND**  
12 **AMENDING THE FISCAL YEAR 2016-2017 CAPITAL BUDGET (ORDINANCE**  
13 **20160914-002) TO TRANSFER IN AND APPROPRIATE GRANT FUNDS FOR**  
14 **REPAIRS TO CITY FACILITIES AND REPLACEMENT OF CITY PROPERTY**  
15 **DAMAGED OR DESTROYED BY THE FLOODING OF MAY AND OCTOBER**  
16 **2015.**

18 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

20 **PART 1.** Council accepts grant funds from the Texas Department of Public Safety in the  
21 amount of \$1,547,397 for repairs to City facilities and replacement of City property  
22 damaged or destroyed by the flooding of May and October 2015.

23 **PART 2.** Council amends the Fiscal Year 2016-2017 Operating Budget Special Revenue  
24 Fund (Ordinance No. 20160914-001) to appropriate \$1,547,397 for the following  
25 departments: Austin Energy \$517,735, Austin Resource Recovery \$232,666, Aviation  
26 \$45,228, Management Services \$3,130, Parks and Recreation \$559,644, and Watershed  
27 Protection \$188,994 for repairs to City facilities and replacement of City property  
28 damaged or destroyed by the flooding of May and October 2015.

29 **PART 3.** Council amends the Fiscal Year 2016-2017 Capital Budget (Ordinance No.  
30 20160914-002) to transfer in and appropriate \$1,237,994 for the following departments:  
31 Austin Resource Recovery \$1,011,015 and Austin Water \$226,979 for repairs to City  
32 facilities and replacement of City property damaged or destroyed by the flooding of May  
33 and October 2015.
