## PROPOSAL

Demolish a ca. 1930 house.

## ARCHITECTURE

One-story, rectangular-plan, front-gabled frame bungalow with a semi-inset front-gabled porch on plain square wood posts; single and paired 1:1 fenestration.

## RESEARCH

The house appears to have been built in 1930. The first owners and occupants were Alfred and Alice Kleinschmidt, who lived here until around 1936. Alfred Kleinschmidt was the son of Conrad Kleinschmidt, with whom he operated a delicatessen in the 800 block of Congress Avenue. The 1930 U.S. Census shows Alfred still living in his parents' home on San Jacinto Street, so this house was likely the first house that he owned after marrying. Alfred Kleinschmidt and his father had their owned restaurant on Congress Avenue until around 1933; the 1935 city directory shows Alfred Kleinschmidt as a cook at the Pik-A-Rib restaurant in the 900 block of Congress Avenue. With them lived Marie Shaw, Alfred's sister-in-law. Marie Shaw was a waitress at the Driskill Hotel.

The house had a series of renters from the late 1930s into the early 1940s, including a salesman for the Texas Public Service Company, the city's natural gas utility, a cashier for an auto parts store, and a carpenter. Around 1943, Luther and Sallie Shelton moved into the house, first as renters. Luther Shelton was a shovel operator for the City Street and Bridge Department, then became a dragline operator for the LCRA, beginning around 1948, a job he maintained for the rest of his career. He and Sallie lived in this house until around 1959.

From around 1959 until around 1987, the house was owned and occupied by Basilio and Juanita Gonzales. Basilio ("Frank") Gonzales was a mechanic for Ward Body Works on S. Congress Avenue; the firm manufactured vehicle bodies.

## STAFF COMMENTS

The house is contributing to the West Line National Register Historic District.

The house has retained a high degree of integrity of materials, but does not qualify as a historic landmark on its individual merits.

The house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a frame bungalow with no other architectural distinction, and does not appear to have architectural significance.
- b. **Historical association.** The house has had a number of owners and renters over the years, including a restaurateur, a natural gas salesman, a shovel operator, and an auto body mechanic, none of whom appear to have significant historical associations.
- c. **Archaeology.** The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value.** The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image,

or cultural identity of the city, the historic district, or a particular demographic group.

- e. **Landscape feature.** The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

#### **STAFF RECOMMENDATION**

---

Strongly encourage rehabilitation and adaptive re-use, through consideration of the demolition delay for contributing properties within historic districts; this house represents an intact example of a late 1920s – early 1930s bungalow in form and design and reflects the historical context of this neighborhood. While there is likely not sufficient evidence and justification to designate this house as an individual landmark, every effort and consideration should be made to preserve and adaptively re-use this house. Staff then recommends relocation over demolition. If the Commission votes to release the permit, then staff recommends that the applicant complete a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, and that the Commission review the plans for any new construction proposed for this site prior to release of the permit.

**BIOGRAPHICAL NOTES:****Alfred H. and Alice Kleinschmidt (ca. 1930 – ca. 1936)**

The 1930 U.S. Census shows Alfred Kleinschmidt as the 25-year old son of Klein and Hulda Schmidt [sic], who owned their home worth \$3,500 at 1505 San Jacinto Street in Austin. Alfred Kleinschmidt had been born in Texas, and was a waiter at a delicatessen. Both his parents had been born in Germany – his father was a lunch man at a delicatessen and his mother had no occupation listed. Alfred had an older sister, Othelia, 30, who had been born in Texas, and was a saleslady at a drug store.

The 1940 U.S. Census shows Alfred and Alice Kleinschmidt as the renters of the house at 3706 (?) Wabash Avenue in Austin. Alfred Kleinschmidt was 35, had been born in Texas, and was a retail beverage salesman. Alice Kleinschmidt was 33, had been born in Texas, and had no occupation listed. They had a daughter, Linda, 6 months. With them lived Alfred's sister-in-law, Marie Shaw, 31, who was single, had been born in Texas, and worked as a cashier in a hotel.

The 1940 U.S. Census shows L.E. and Sallie Shelton as the renters of an apartment at 911 West Lynn Street. L.E. Shelton was 36, had been born in Texas, and was a shovel operator for the City. Sallie Shelton was 38, had been born in Texas, and was a seamstress for a ready-to-wear clothing store. Their children are listed as Frank, 14; Joyce E., 11; and Christine, 10. All the children had been born in Texas.

The 1930 U.S. Census shows Luther E. and Sally Shelton as the renters of the house at 1304 W. 5<sup>th</sup> Street in Austin. Luther Shelton was 26, had been born in Texas, and worked for the city street department. Sally Shelton was 28, had been born in Texas, and had no occupation listed. They had 3 children: Frank, 4; Joyce, 1; and Evelyn, 4 months. All the children had been born in Texas.

**LUTHER E. SHELTON**

Luther E. Shelton, 63, 5704 Joe Sayers, died in a local hospital Tuesday.

He had been a resident of Austin 35 years, and was a member of the West Austin Baptist Church. He was a member of the LCRA Employees Club, Hill City Lodge No. 456 A.F.&A.M., Scottish Rite Bodies, Ben Hur Temple of Austin, Honorary member of the Order of DeMolays, Loyal Moose Lodge of Austin, and the International Union of Operating Engineers No. 450. Since 1948 he had been with the LCRA as drag line and heavy equipment operator.
