# HISTORIC LANDMARK COMMISSION JUNE 26, 2017 DEMOLITION AND RELOCATION PERMITS HDP-2017-0292 909 E. 44<sup>TH</sup> STREET

#### **PROPOSAL**

Demolish a ca. 1926 house.

#### ARCHITECTURE

One-story, front-gabled frame bungalow with a partial-width front-gabled independent porch; single 1:1 fenestration.

## RESEARCH

The house appears to have been built around 1926; the first owners and occupants were Charles D. Bragg and his wife, Rhoda. Charles D. Bragg was a salesman for McKean-Eilers, a wholesale dry goods store on Congress Avenue. The Braggs lived here from around 1926 until around 1918. The house was vacant in the late 1920s, the owned and occupied by Beverly H. and Mabel McGuire, who lived here for only a year or two in the early 1930s. Beverly H. McGuire was a conductor for the Southern Pacific Railroad.

Thomas M. Neill and his wife, Ruth, owned and occupied the house in the early- to mid-1930s. Thomas Neill was an auto salesman. A barber, Leslie F. McClish, and his wife, Patsy, rented the house in the late 1930s and early 1940s. McClish worked for Samuel New, who had his barber shop at 408 ½ E. 43<sup>rd</sup> Street. Patsy McClish operated a beauty salon in the same building for a number of years in the late 1930s.

Since the early 1940s, the house has had a series of renters and owners, none of them for very long tenancies. The occupants have included a painter at Austin State Hospital, a tractor operator at a limestone quarry, a serviceman for a butane company, and the assistant manager of a television sales business.

# STAFF COMMENTS

The house is outside the bounds of the Hyde Park Historic District, and was listed with no priority for research in the Comprehensive Cultural Resources Survey (1984).


The house does not meet the criteria for landmark designation as set forth in City Code:

- a. **Architecture.** The house is a frame 1920s bungalow, a common style. The house has no architectural distinction within its architectural style.
- b. **Historical association**. The house had a series of owners, including a dry goods salesman, a railroad conductor, a car salesman, and a barber. There do not appear to be significant historical associations.
- c. **Archaeology**. The house was not evaluated for its potential to yield significant data concerning the human history or prehistory of the region.
- d. **Community value**. The house does not possess a unique location, physical characteristic, or significant feature that contributes to the character, image, or cultural identity of the city, the Hancock neighborhood, or a particular demographic group.
- e. **Landscape feature**. The property is not a significant natural or designed landscape with artistic, aesthetic, cultural, or historical value to the city.

## STAFF RECOMMENDATION

Encourage rehabilitation and adaptive re-use, then relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package. The house, while maintaining a high degree of integrity, is a relatively common bungalow type and lacks the historical significance necessary for individual designation as a historic landmark. The house would be contributing to a potential historic district, so staff recommends consideration of alternatives to demolition.

# Charles D. and Rhoda Bragg (ca. 1926 – ca. 1928)

The 1920 U.S. Census shows Charles D. and Rhoda Bragg as the renters of the house at 1207 Willow Street in Austin. Charles D. Bragg was 35, had been born in Texas, and was an entry clerk at a dry goods store. Rhoda Bragg was 29, had been born in Texas, and had no occupation listed. They had 3 sons: Victor, 10; Jacob S., 7; and Joe W., 4. All the boys had been born in Texas and none had an occupation shown.

The Bragg family appears as the renters of the house at 500 E. 8<sup>th</sup> Street in Austin in the 1930 U.S. Census. C.D. Bragg was 46, had been born in Texas, and was a clerk in a store. Rhoda Bragg was 40, had been born in Texas, and had no occupation listed. Their children were Victor, 21, a book-keeper in a bank; Shelby, 18; Joe, 14; and Betty A., 2. All of the children had been born in Texas.

Rhoda Bragg was living at 1000 E. 1<sup>st</sup> Street at the time of her death in 1961. She was born in 1890 in Texas and was a housewife.

His 1967 death certificate shows that Charles David Bragg was born in 1884 in Cotulla, Texas. He was living at 1000 E. 1<sup>st</sup> Street at the time of his death, and was a clerk.

Mrs. Rhoda Bragg, of 1000 East First Street, died in a local hospital Friday. She is survived by her husband, C. D. Bragg of Austin; one daughter, Mrs. Betty Bauhs of Austin; two sons, Jacob Shelby Bragg of Freer and Joe W. Bragg of Houston; nine grand-children; and 8 great great grand-children.

Funeral services will be held Sunday afternoon at the Cook Funeral Home.

# Beverly H. and Mabel McGuire (ca. ca. 1929 - ca. 1931)

The 1930 U.S. Census shows Beverly H. and Mabel S. McGuire as the owners of this house, which was worth \$2,800. Beverly H. McGuire was 42, had been born in Texas, and was a railroad conductor. Mabel McGuire was 37, had been born in Texas to Mississippi-born parents, and had no occupation listed. They had 2 sons: Beverly H., Jr, 19; and John, 16. Both boys had been born in Texas and neither had an occupation listed.

Mabel McGuire died in Houston in 1964. Her death certificate shows that she had been living in Woodville, Texas, and was a married housewife. She had been born in 1892 in Hearne, Texas. She was buried in Hearne. Beverly H. McGuire was also born in Hearne, Texas in 1887, and died in Woodville, Texas in 1973. He was a retired conductor for the Southern Pacific Railroad. There were no obituaries in the Austin newspapers.

## Thomas M. and Ruth L. Neill (ca. 1931 – ca. 1938)

Thomas M. and Ruth L. Neill appear in the 1930 U.S. Census as the renters of a duplex at 1700 W. 6<sup>th</sup> Street in Austin. Thomas M. Neill was 37, had been born in Texas to Arkansas-born parents, and was an auto salesman. Ruth L. Neill was also 37, had been born in Texas, and had no occupation listed. They had 2 children: Emogene, 10; and Harry Joe, 5. Both children had been born in Texas.

The 1940 U.S. Census shows Tom M. and Ruth L. Neill living in a rented house at 1506 Travis Heights Boulevard in South Austin. Tom M. Neill was a 47 year old manager of a used car company. Ruth Neill was 47 and had no occupation listed. Their daughter, Emogene, 21, was a receiving clerk in a department store. Their son, Joe, 16, had no occupation listed.

Thomas M. Neill died of tuberculosis in June, 1943. He was living at 1102 Woodland Avenue in South Austin, and was a married filling station operator who had been born in 1893 in Texas. Ruth Neill was living on Burnet Road at the time of her death in 1970. She was born in Cisco, Texas in 1893, and was a retired auditor. Her daughter, Emogene, married Leonard Lundgren, a noted Austin architect whose principal commercial work was the Town Lake Holiday Inn, which was the tallest concrete building in the world at the time of its construction, and was the model for the design of Holiday Inn hotels throughout the world in the 1960s.

NEILL—Thomas M. Neill died Sunday. He was associated with the Thompson Motor company for eight years and for the past two years had operated a service station at 1123 S. Congress.

Survivors include his widow; one son, Joe Neill, Austin; one daughter, Mrs. L. J. Lundgren, Evansvillë, Ind.! parents, Mr. and Mrs. J. T. Neill of Gorman; six sisters, Mrs. Lester McDonald, Mrs. Ed Sutton, Mrs. Dick Gray, and Mrs. Millie Blackburn Slater, all of Gorman; Mrs. M. J. Benefield, Brady, and Mrs. Clyde King of Stephenville; two brothers, J. H. Neill of Loraine and John A. Neill of Lubbock.

Funeral services were held from the Weed-Coley Funeral home at 10 a. m. Monday. Dr. Kenenth Pope officiated and burial was in Austin Memorial park.

Pallbearers were Marshall Wilson and O. B. Burksof Austin, Neil Moore, Eastland, J. A. Nichols, Fort Worth, A. D. Rogers, Houston and Lester McDonald of Gorman.

Leslie F. and Patsy T. McClish are shown as the renters of this house in the 1940 U.S. Census. Leslie F. McClish was 35, had been born in Texas, and was a barber. Patsy T. McClish was 31, had been born in Texas, and was an operator in a beauty shop. They had no children listed with them.

The 1930 U.S. Census shows Leslie F. McClish living as a lodge in a boarding house in San Antonio. He was 24, had been born in Texas, and was a student at a barber college. Most of the other residents of the boarding house were also associated with the barber college.

Leslie Franklin McClish died in 1982. His death certificate shows that he was born in 1905 in Texas, and was living at 911 E.  $54^{th}$  Street at the time of his death. He was a barber. Patsy McClish died in 1987 in Medina County, Texas. There was no obituary in the Austin newspapers.
