

AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, JUNE 8, 2017

Invocation: Rabbi Mendy Levertov, Chabad Austin

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, June 8, 2017 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 10:14 a.m. Council Members Garza and Kitchen were absent.

Authorize negotiation and execution of a professional services agreement with JACOBS ENGINEERING GROUP, INC., (staff recommendation) or one of the other qualified responders to Request for Qualifications Solicitation No. CLMP221, to provide engineering services for the Austin Community College Chiller Plant, in an amount not to exceed \$3,000,000. (District 4) (Notes: This contract will be awarded in compliance with City Code Chapter 2-B (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 15.80% MBE and 15.80% WBE participation.)

(Notes: This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established.)

The motion authorizing negotiation and execution of a contract through the State of Texas Department of Information Resources cooperative purchasing program with Time Warner Entertainment – Advanced Newhouse Partnership doing business as Time Warner Cable was approved on consent on Council Member Flannigan's motion, Council Member Alter's second on a 9-0 vote. Council Members Garza and Kitchen were absent.

Authorize negotiation and execution of a 36-month contract with ENVISIONWARE, INC., to provide a single integrated solution for computer reservations, pay for print, scanning, photocopying, and fine and fee payment services, for a total contract amount not to exceed \$548,169. (Notes: This contract is exempt from the City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program; therefore, no subcontracting goals were established.)

The motion authorizing negotiation and execution of a contract with Envisionware, Inc. was approved on consent on Council Member Flannigan's motion, Council Member Alter's second on a 9-0 vote. Council Members Garza and Kitchen were absent.

27. Authorize negotiation and execution of a 36-month contract with REDQUARTZ USA, LLC., or one of the other qualified offerors to Request For Proposals PAX0137, to provide a safety management system, in an amount not to exceed \$222,000, with three 12-month extension options in an amount not to exceed \$51,000 per extension option, for a total contract amount not to exceed \$375,000. (Notes: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods and services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established.)

The motion authorizing negotiation and execution of a contract with Redquartz USA, LLC was approved on consent on Council Member Flannigan's motion, Council Member Alter's second on a 9-0 vote. Council Members Garza and Kitchen were absent.

28. Approve ratification of a contract with HENSEL PHELPS CONSTRUCTION COMPANY, for emergency repair and roof replacement, in an amount not to exceed \$253,095. (Notes: Emergency contracts are exempt this contract is exempt from the City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program; therefore, no subcontracting goals were established.)

The motion approving ratification of a contract with Hensel Phelps Construction Company was approved on consent on Council Member Flannigan's motion, Council Member Alter's second on a 9-0 vote. Council Members Garza and Kitchen were absent.

Authorize negotiation and execution of a 12-month contract with JOURNAL TECHNOLOGIES, INC., or one of the other qualified offerors to Request For Proposals JTH0306, to provide a court case management system in an estimated amount of \$1,025,000, with four 12-month extension options for maintenance and support in an amount of \$455,000 per extension option, for a total contract amount not to exceed \$2,845,000. (Notes: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9 D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods and services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established. However, the recommended firm has identified subcontracting opportunities and the resulting contract will include 7% MBE participation.)

The motion authorizing negotiation and execution of a contract with Journal Technologies, Inc. was approved on consent on Council Member Flannigan's motion, Council Member Alter's second on a 9-0 vote. Council Members Garza and Kitchen were absent.

30. Authorize negotiation and execution of a 12-month contract through the General Services Administration cooperative purchasing program with GEOGRAPHICAL INFORMATION SERVICES, INC., to provide geographic information systems data maintenance services, in an estimated amount of \$138,600, with three 12-month extension options in an estimated amount of \$138,600 per extension option, for a total contract amount not to exceed \$554,400. (Notes: This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this procurement, there were no subcontracting opportunities; therefore, no subcontracting goals were established.)

The motion authorizing negotiation and execution of a contract with Geographical Information Services, Inc. was approved on consent on Council Member Flannigan's

motion, Council Member Alter's second on a 9-0 vote. Council Members Garza and Kitchen were absent.

Authorize negotiation and execution of a 12-month contract with AUSTIN COMMUNITY RADIO DBA KAZI FM 88.7, or one of the other qualified offerors to Request For Proposals SMB0106, to provide radio broadcast of City meetings, in an estimated amount of \$113,220, with four 12-month extension options in an estimated amount of \$80,250 per extension option, for a total contract amount not to exceed \$434,220. (Notes: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program.
