2. CITIZEN COMMUNICATION: GENERAL

a. Dusty Harshman addressed the Commission as an AISD Facilities and Bond Planning Advisory Committee (FABPAC) member and provided an update on recent AISD Board of Trustee actions related to the AISD Facilities Master Plan.
