<p>TBG Partners began work on the Town Lake Metropolitan Park project in 1999 as the design consultant for the Master Plan, Phase I, and Phase II of the project. This amendment is for The Alliance Children's Garden Phase II improvements for the Town Lake Metropolitan Park redevelopment project. The Alliance Children's Garden will provide a children's activity area with educational, interactive, and artistic play features that complement the existing Liz Carpenter Fountain.</p> <p>The purpose of this amendment is to provide additional authorization for added professional services for the fountain improvements, updates to site development permit, and coordination and collaboration with the construction manager-at-risk contractor. This request is for the remaining scope of work that should complete TBG's contract. Total expected cost for this request is \$180,000 with a contingency of \$62,000 for unforeseen design costs associated with TBG's completion of work.</p> <p>This amendment has been approved by the City's Change Control Committee. The Change Control Committee was established to comply with Council Resolution No. 20120126-048, which required the establishment of consistent criteria and process to evaluate contractual changes for all contracts administered by the Capital Contracting Office. The Change Control Committee is comprised of management-level subject matter experts.</p> <p>This project is located in zip code 78704 (District 9). This project is managed by the Public Works Department.</p>
