

## M/WBE Summary

Participation subgoals in the solicitation were 1.90% African American, 9.00% Hispanic, 4.90% Native Asian; 15.80% WBE. Seven firms submitted qualifications statements and submittals were opened on May 3, 2017. Of the seven of submittals received, one was from a MBE/WBE certified firm.
