This action will approve the proposed South Congress Preservation and Improvement District Service and Assessment Plan and Budget for 2018, as provided to the City by the South Congress Improvement Association. State law requires City Council approval of the Service and Assessment Plan and Budget, which serves as the basis for the proposed assessment roll. The PID assessment will provide services in the following categories: Public Safety; Infrastructure and Physical Environment (maintenance and improvements); Marketing, Fundraising and Economic Development, and; Administration.

The total projected revenue within the budget is \$183,664. This estimate is based on the certified real property tax appraisal roll from the Travis Central Appraisal District (TCAD). Adjustments to the roll may be required based on new information from TCAD and Council action as a result of the August 10, 2017 public hearing. Approval of the proposed PID service and assessment plan and budget and the ordinance adopting an assessment rate and proposed assessment roll are the first steps in the annual process of approving PID assessments and subject through City Council approval in the FY 2018 Budget.
